## GOVERNMENT OF THE PEOPLE'S REPUBLIC OF BANGLADESH MINISTRY OF PORTS, SHIPPING AND IWT

#### NOTIFICATION

Dacca, the 17th July, 1978.

No. S. R. O. 200-L/78.—In exercise of the powers conferred by section 82 of the Inland Shipping Ordinance, 1976 (LXXII of 1976), the Government is pleased to make the following rules to provide for the rates according to which fees payable in respect of survey and registry are to be calculated in the case of all places of surveys and registry, the same having been previously published as required by sub-section (1) of the said section, namely:

- These rules may be called the Inland Ships (Survey and Registration Fees) Rules, 1978.
- 2. The fees payable in respect of surveys and registry of inland ships shall be calculated in the case of all places of surveys and registry at the rates shown in Schedule I and Schedule II below:

3. An additional fee at rate double the travelling allowance and daily allowance admissible to the Surveyor under normal rules of the Government shall be payable where the Surveyor may be required to undertake survey of an inland ship at a place other than the places declared as the places of survey.

4. The fees shall be deposited to the head "XXIV-Ports and Pilotage".

5. In the revised rules relating to the survey of inland mechanically propelled vessels published under Notification No. 50—Mne, dated the 22nd November 1930, rule 12 shall be omitted.
