The following amendments in the Import Trade Control Schedule (Import Commodity List) already notified under S.R.O. 201-L/79, dated 17th July 1979, in the Gazette, Extraordinary, by the Ministry of Commerce, is hereby notified for the information of all concerned:

### Dacca, the 17th July, 1979.

No. S.R.O. 201-L/79.—In exercise of the powers conferred by sub-section (1) of section 3 of the Imports and Exports (Control) Act, 1950 (XXXIX of 1950), the Government is pleased to make the following amendment in this Ministry's notification No. S.R.O. 134-L/79, dated the 18th May, 1979, namely:-

In the aforesaid Notification, in Schedule I-

- (a) in item 8, for the words and letters "the C and F value of that" the words and letters "the reading materials shall not contain any obscene and objectionable matters and C and F value of the" shall be substituted; and
- (b) in item 16, in clause (a), for the comma and word ", journals" the words "and journals which do not contain any obscene objectionable matters" shall be substituted.

## PUBLIC NOTICE No. 39(70)/IMPORT Dacca, the 23rd July, 1979.

The following amendments in the basis of industrial licensing in 1979-80 as published in Annex 4 of the Import Policy Order, 1979-80, are hereby notified for the information of all concerned industrial units:—

- 1. The source of procurement of cotton yarn (below 20 counts and above 80 counts) as mentioned in para 9 of Annex 4, shall be as under:—
  - Out of the total share calculated on the basis of Taka 1,500 per loom, 70% (seventy per cent) of the total share shall be licensed under cash and the balance 30% (thirty per cent) under OECF loan. The particulars of OECF loan shall be announced later.
- As mentioned in para 10, the list of permissible items of pesticides as received from the Ministry of Agriculture and Forest has already been announced in this office Public Notice No. 37(79)/Import, dated the 21st July 1979 as Annex 39 to the Import Policy Order, 1979-80.
- 3. Recognised industrial units under "Specialised Textiles (Cotton group)" shall be licensed for cotton yarn (below 20 counts and above 80 counts) at 50% (fifty per cent) of the entitlement of cotton yarn under cash and the balance 50% (fifty per cent) under "EEC/IDA Special Action Credit No. 5-BD". The designated bank for cotton yarn under this credit is Rupali Bank and the respective F. E. Circular is No. 39, dated 16th July 1979, issued by the Bangladesh Bank, Head Office, Dacca.
- The source of procurement for the industrial licensing mentioned at sub-para (iv) of para 29 shall read as "under cash" instead of "under 8th IDA Commodity Credit".
- 5. The name of the 'Aluminium Utensil' industry shown against serial No. 2 under Engineering Group of Industries in sub-para (ix) of para 29 (page 2711 of the Import Policy Order) shall be deleted and the name of 'Aluminium Industry' shall be inserted at serial No. 133 (page 2710 of the Import Policy Order) under Engineering Group in sub-para (vii) of para 29. In other words the recognised industrial units under Aluminium Industry shall be licensed at 100% (hundred per cent) of their entitlement of raw and packing material (excluding aluminium ingot) under cash. Separate notification shall be issued in case private sector units are allowed to import aluminium ingot under cash.
- Recognised industrial units under "Special Textiles (Cotton group) and Specialised Textiles (Synthetic and silk group) Industries" shall be licensed for Chemicals or Dyes of both under STA (Andr-CIE) Barter

at 75% (seventyfive per cent) of their entitlement for Dyes and Chemicals and the balance 25% (twenty five per cent) of their entitlement for Dyes and Chemicals under cash.

- Para 29 shown against Repeat Licensing shall read as para No. 30 and the subsequent paragraphs shall be re-numbered as 31, 32 and 33 respectively.
- 8. In Annex 2 (Engineering Group of Industry)-
  - (a) against the industrial sector mentioned at Sl. No. 1 (Accumulator) a ',' comma shall be *inserted* in between the words "Lead" and "Antimony" mentioned at Sl. No. 1 under coloumn 3. The same printing mistake has also occurred in the Import Policy Order, 1978-79 which should also be corrected.
  - (b) against Sl. No. 424 (Umbrella), the following raw material item shall be inserted after the existing items under coloumn 3:
     5. Umbrella fittings (excluding ribs).
