"5. **Withdrawal of prosecution**—Permission for withdrawal of prosecution under sub-section (4) of section 10 of the Act shall in relation to a public servant and other citizen's specified in Column 2 of the Schedule be accorded by the person or, as the case may be, the Divisional Committee specified in Column 3 thereof"
