No. S.R.O. 209-L/77/S-VI/1(66)/77.—In exercise of the powers conferred by sub-section (1) of section 3 of the Shops and Establishments Act, 1965 (E.P. Act VII of 1965), the Government is pleased to suspend the operation of

the provisions of sections 4, 8, 10 and 11 of the said Act in respect of the Faridpur Chinikal (Project), Faridpur, for a period of one month twenty-three days subject to the following conditions, namely:—

Conditions:

- (1) The workers required to work overtime shall be paid wages at double the rate of ordinary wages of working beyond the normal working bours.
- (2) The workers deprived of weekly holidays shall be allowed compensatory weekly holidays within a month after the expiry of the exemption period.

NOTIFICATION

No. S.R.O. 210-L/77/356/D/Cus.—In exercise of the powers conferred by section 19 of the Customs Act, 1969 (IV of 1969), the Government is pleased to direct that the machinery as defined in, and the spares of such machinery falling within the description of, this Ministry's Notification No. S.R.O. 108(D)Cus/73, dated the 14th June, 1973, and falling within the Heading Nos. specified in the Table of the aforesaid Notification shall be exempt from so much of the customs-duties leviable thereon as in excess of 2½% ad valorem in the case of machinery and 10% ad valorem in the case of spares, if imported for setting up industries in less developed areas as specified in Schedule I to this Notification and subject to the following conditions, namely:—

- (i) The concessions herein allowed shall be admissible in the private sector to the industries mentioned in column (2) of Schedule II to this Notification located against the areas mentioned in column (1) of the said Schedule;
- (ii) The concessions herein allowed shall apply only to the machinery including spares imported for initial installation of a project approved by the competent authority;
- (iii) The concession herein allowed shall also be admissible for the spares of machinery only on the specific recommendation of the Ministry of Industries or the Department of Industries to the effect that the imported spares of machinery are required for the newly set up industry or, as the case may be, by the industry already established in the areas specified in column (1) of Schedule II to this Notification;
- (iv) The concession for the spares of machinery shall be available for the next five years beginning the 1st day of March, 1977.

2. This Notification shall take effect on and from the 1st day of March, 1977.
