(2) The objection or suggestion, if any, received under sub-rule (1) shall be forwarded to such officer as may be appointed by the Election Commission in this behalf who, after making such enquiries as he may consider necessary, shall give his decision within a period of fifteen days from the date of the receipt of objection or suggestion from the delimitation officer.

(3) The delimitation officer shall publish the final list of wards, prepared under sub-section (5) of section 20 and the final list of wards grouped under section 20A, at his office and at the office of the Corporation and at such other place or places as he may consider necessary and shall forward attested copies thereof to the Election Commission who shall publish the lists of wards in the official Gazette.";
