Whereas it appears that accused (1) Khair Ahmed, (2) Naser Ahmed, both son of Ramjan Ali of North Shikalbaha, P.S. Patiya, Dist. Chittagong, (3) Abdul Hakim, son of Muktul Hussain of Charandip, P.S. Boalkhali, Dist. Chittagong and (4) Mohd. Ali, son of Imam Sharif of Morium Nagar, P. S. Rangunia, Dist. Chittagong, have been involved in Kotwali P.S. Case No. 6(6)75 and G.R. Case No. 162/75, u/s 407/37, B.P.C. and they are required for the purpose of trial in the Summary Martial Law Court, Chittagong Hill Tracts;

And whereas this Summary Martial Law Court, Chittagong Hill Tracts, has reason to believe that the said accused persons are concealing themselves to avoid appearance or arrest for the said purpose;

Now, therefore, in exercise of powers conferred upon me by MLR No. 3(7)/75, I, Md. Nur Hossain, Member, Summary Martial Law Court, Chittagong Hill Tracts and Magistrate, 1st Class, Rangamati, do hereby direct the said accused persons to appear before this Court on or before 5th August 1978, failing which they will be tried *in absentia* and the whole of their properties may be forfeited to the State.

No. S.R.O.215-L/78/LSWVI/1(90)/77.—In pursuance of the provisions of sub-rule (4) of rule 36 of the Industrial Relations Rules, 1977, read with sub-rule (1) thereof, the Government is pleased to make the following amendment in this Ministry's notification No. S.R.O. 50-L/78/LSWVI/1(90)/77, dated the 9th March, 1978, namely:—

In the aforesaid Notification, in the penal of members of Labour Court, Khulna, under the heading "Representatives of Employers",

(a) for the entries in serial 1 and the entries relating thereto the following shall be *substituted*, namely:—
