No. S. R. O. 224-L/78/13-Excise.—In exercise of the powers conferred by rule 12-A of the Excises and Salt Rules, 1944, the National Board of Revenue is pleased to grant to Mennonite Central Committee, Saidpur, Rangpur, a rebate of excise duty on hessian falling under Item No. 44 of the First Schedule to the Excises and Salt Act, 1944 (I of 1944), used in the manufacture of such goods specified in column 1 of the Table below and exported out of Bangladesh on or after 7th September 1977, at the rate specified against such goods in column 2 of that Table :
