ORDER

Dhaka, the 3rd June 1984

No. S.R.O. 227-L/84/841/Cus.—In exercise of the powers conferred by clause (b) of section 21 of the Customs Act, 1969 (IV of 1949), and sub-section (2) of section 4 of the Sales Tax Ordinance, 1982 (XVIII of 1982), the National Board of Revenue is pleased to authorize the delivery without payment of the whole of the customs-duties chargeable on, and grant exemptions from the payment of the whole of the sales tax payable in respect of, the raw materials, components, spares and accessories required for local manufacture of irrigation pump sets consisting of diesel engines, pumps, couplings, trolleys and those items of spares, components and accessories which are supplied with the set as per standard practice and for manufacture of diesel engines meant for road transport, marine engines and all other types of diesel engines, when imported by the Bangladesh Diesel Plants, Joydebpur, Dhaka.

2. This order shall be deemed to have come into force on the 1st day of May, 1984, and shall continue up to the 30th day of November, 1984 subject to the condition laid down in Cabinet Division Letter No. 10-79-ECNEC/56(6), dated the 17th May, 1980.

No. S.R.O. 228-L/84/S-IX/SE-583.—In exercise of the power conferred by sub-section (1) of section 3 of Shops and Establishments Act, 1965 (E. P. Act VII of 1965), the Government is pleased to suspend the operation of clause (a) of section 10 of the said Act in respect of those commercial esatablishments, who are members of the Metropolitan Chamber of Commerce and Industry, Dhaka, and the Bangladesh Employers' Association and where five and a half working days in a week are observed, for the month of Ramazan in 1984, subject to the following conditions, namely:—
