Dacca, the 5th August, 1977.

No. S.R.O. 237-L/77/360/D/Cus.—In exercise of the powers conferred by section 19 of the Customs Act, 1969 (IV of 1969), and in supersession of the Notifications Nos. 10-C, dated the 14th March, 1955 and 24-C, dated the 31st August, 1956, the Government is pleased to exempt from the whole of the customs-duty leviable on fresh fish which is processed, frozen, preserved or canned and is experted from Bangladesh on or after the 1st day of July, 1977.

No. S.R.O. 238-L/77/361/D/Cus.—In exercise of the powers conferred by section 19 of the Customs Act, 1969 (IV of 1969) and sub-section (1) of section 7 of the Sales Tax Act, 1951 (III of 1951), the Government is pleased to exempt cotton seeds falling under the Heading No. 12-01 of the First Schedule to the Tariff Act, 1934 (XXXII of 1934), from the whole of the customs-duties and sales tax leviable thereon provided such cotton seeds are imported by the Cotton Development Board for the purpose of sowing and a

certificate from the Ministry of Agriculture is produced to the Collector of Customs at the time of clearance to the effect that the imported cotton seeds shall be used exclusively for the purpose of sowing.

Now, therefore, in exercise of the powers conferred by Regulation 3 (7) of the Mar ial Law Regulation No. I, of 1975 this Special Martial Law Court No. I, at Ganabhaban, Dacca, do her by direct—

That the above accused persons to appear in this Court at Dacca on 19th August 1977, at 10.0) a m. in the Mart al Law Case No 91 of 1977, fa ling which they will be trie in absentia and their properties may be forfeited to the Government.
