The Committee will examine the existing provisions of Legal Advisers Scheme, 1972 requiring the "institutions, particularly where the Government is involved, directly or indirectly," to channelise all appointments of Legal Advisers through a Board constituted under the aegis of Ministry of Law and Parliamentary Affairs and recommend whether the Legal Advisers Scheme, 1972 should be continued or whether the agencies concerned should be empowered, in substitution, to appoint Legal Advisers under specified guidelines.

PROCLAMATION

Whereas it appears that accused (1) Aminul Hoque, son of Imanuddin Ahmed of Gabindapur, P.S. Ramgonj, Dist. Noakhali, is required for the purpose of trial under Regulation 11 and 11/9 of the Martial Law Regulation No. I of 1975;

And whereas this court has reason to believe that the said accused Aminul Hoque is absconding or concealing himself to avoid appearance or arrest for the said purpose;

Now, therefore, in exercise of the powers conferred by Regulation 3(7) of the Martial Law Regulation No. I of 1975, this Special Martial Law Court No. I at Ganabhaban, Dacca, do hereby direct:

That the above accused person do appear in this court on 12th September 1978, failing which he will be tried *in absentia* in Martial Law Case No. 29/78 and his property may be confiscated to the Government.

No. 512-P.—Whereas it has been made to appear to me that Mr. Md. Maniruzzaman, son of late Md. Jan, Vill. Gowripur, P. S. Kotwali, Dist. Dinajpur, is required for the purpose of an enquiry and other proceedings for D.A.B. MLGR-9/77 (Kotwali P. S. Case No. 47, dated 28th June, 1977) for an offence punishable under 11 of the Martial Law Regulations, 1975;

And whereas I have reasons to believe than the said Md. Maniruzzaman is absconding or concealing himself or remaining abroad to avoid appearance for the said enquiry and proceedings;
