No. S.R.O. 239-L/77/362/D/Cus.—In exercise of the powers conferred by section 19 of the Customs Act, 1969 (IV of 1969), and section 7 of the Sales Tax Act, 1951 (III of 1951), the Government is pleased to exempt the goods specified in column (2) of the Table below and falling under the Heading Nos. of the First Schedule to the Tariff Act, 1934 (XXXII of 1934), as specified in column (1) of the said Table from the whole of the customs-duties and sales tax leviable thereon if they are imported between the 11th August, 1977 and the 14th September, 1977 (both days inclusive).
