এস, আর, ও, নং ২৩৯-আইন/৯৪—Insurance Act, 1938 (IV of 1938) এর section 114 এর sub-section (1) এ প্রদন্ত ক্ষমতাবলে সরকার Insurance Rules, 1958 এ নিম্নরপ্র প্রধিকতর সংশোধন করিল, যাহা উক্ত section এর sub-section (1) এর বিধান মোতাবেক ইতিপূর্বে বাংলাদেশ গেজেটে প্রকাশিত হইয়াছিল, যথা :—

উপরি-উক্ত Rules এর—(ক) rule 3A বিল, ত হইবে ;

(খ) rule 4A এর পরিবর্তে নিন্নর প rule 4A প্রতিস্থাপিত হইবে, যথা ৯-

"4A. Paid-up capital of an insurance company and share holding.—
(1) 50% of the total paid-up capital shall be contributed by the sponsors and the remaining 50% shall be open for public subscription within a period of three years from the date of registration of the company and the sponsors shall furnish under taking to the Controller of Insurance at the time of applying for registration to the effect that before floating of public shares within the aforesaid period they shall obtain commitment from the scheduled banks and financial institutions that any portion of public issue of shares remaining unsubscribed shall be subscribed by the scheduled banks or financial institutions or both making the aforesaid commitment.

Provided that, if the Controller of Insurance has reason to believe upon an application made to him by any company to the effect that due to certain unavoidable circumstances it is unable to float public shares within the aforesaid period, the Controller of Insurance may extend the time for a period not exceeding six months.

Provided further that the portion of the paid-up capital open for public subscription shall, in respect of the companies registered before the commencement of these Rules, be floated within such time as may be specified by the Controller of Insurance failing which the Controller of Insurance may cancel the registration of the concerned company under clause (f) of sub-section (4) of section 3 of the Act.

Provided further that the Controller of Insurance may grant a certificate of registration to a public limited insurance company for carrying on any class of insurance business if the sponsors have contributed their portion of the total paid-up capital.

- (2) No individual or company shall be sponsor or director of an insurance company if, according to the opinion of Bangladesh Bank, he is a defaulter with any bank or financial institution.
- (3) Not more than 20% of the sponsor's contribution to the paid up capital shall be allowed to be subscribed by each sponsor or members of the family of that sponsor.
- (4) Individual sponsor's share shall not be less than five lac taka in case of general insurance company and two lac taka in case of life insurance company.
- (5) Sponsors shall deposit their contribution to the share capital committed by them in any scheduled bank in the name of the company before the company makes the application for registration and furnish certificate from the concerned scheduled bank to the Controller of Insurance with the undertaking that the amount so deposited shall not be withdrawn without the written permission of the Controller of Insurance and there shall not be any lien to such deposit:

Provided that the Controller of Insurance shall not allow any withdrawal other than for the purpose of meeting initial expenditure for formation of the company.";

ELECTION OF DIRECTORS BY PUBLIC SUBSCRIBERS

15A. Qualification of public subscriber directors of insurance companies.—A person who is not otherwise disqualified to be a director of an insurer under the provisions of the Act shall be eligible for election as a director of public subscriber of an insurance company if he holds

such minimum qualifying share as may be determined by the company on account of public subscirption to the paid-up capital at least 6 months before the date of election:

Provided that no company shall fix the minimum qualifying share to be an amount exceeding ten thousand taka.

- 15B. Voters, etc.—(1) The holders of public subscription shares shall elect the Directors under rule 15A.
- (2) The election shall be held at a meeting of the holders of public share and such meeting shall ordinarily be held at the premises of the principal office of the company or where sufficient space is not available for holding the election meeting, such meeting may be held at a suitable place near the principal office of the company.
- (3) The date, time, place and other particulars of election and the number of Directors to be elected shall be circulated sixty days before such election by advertisement in at least two national daily newspapers.
- (4) Where the number of candidates in the election is, on scrutiny, found equal to the number of Directors to be elected, all such candidates shall be declared elected as Directors by the Secretary of the Company and all concerned shall be intimated accordingly.
- (5) The election meeting shall be presided over by the Chairman of the Board of Directors of the company or any Director nominated by him in writing.
 - (6) In the case of contesting election, the Chairman of the meeting shall decide the manner of election.
 - (7) The Chairman of the election meeting shall count or cause to be counted the votes and declare the names of the elected candidates.";

 - "18. Temporary licence of life insurance agent.—(1) Any person who has passed the eighth class of a secondary school may apply to the Controller of Insurance for temporary licence of life insurance agent.
 - (2) An application for temporary licence of life insurance agent undre sub-rule (1) shall be made in form VI.

(3) The holder of a temporary licence of life insurance agent or any person who was at any time granted such licence shall not be entitled to apply for fresh temporary licence:

Provided that nothing in this sub-rule shall apply to a person who during the period when his licence was in force procured life insurance policy of sum insured of at least taka two lac each year, out of which at least 40% percent remains in force on the date of submitting application for another or fresh temporary licence.

- (4) The provisions of sub-rule (1) and (2) shall apply in the case of an application for another or fresh temporary licence of life insurance agent.
- 18A. Renewable licence of life insurance agent.—(1) Whoever possesses the qualification mentioned in rule 18(1) or holds a licence shall be deemed to be a temporary licence within the meaning of rule 18(1) of life insurance agent on the commencement of this rule may, subject to his passing the examination referred to in rule 18B, apply to the Controller of Insurance for renewable licence of life insurance agent.
- (2) An application for renewable licence of life insurance agent under sub-rule (1) shall be made in form VIA.
- 18B. Examination.—(1) There shall be an examination to be called examination for life insurance matters to be held in accordance with the provisions of this rule.
- (2) The examination shall be conducted by such authority as the Government may determine from time to time.
- (3) The time, place, total marks, pass marks, fee and other relevant metters of the examination shall be determined by the examination conducting authority.
- 18C. Licence of general insurance agent.—(1) Any person desiring to obtain a licence of general insurance agent may apply to the Controller of Insurance for such licence.
- (2) An application for licence of general insurance agent under sub-rule (1) shall be made in form VIB.
- 18D. Fees for licences.—(1) The following shall be the fees of licences of insurance agents, namely:—
 - (a) temporary licence of life insurance agent taka fifty;
 - (b) fresh temporary licence of life insurance agent taka fifty;

- (c) renewable licence of life insurance agent taka seventy five;
- (d) licence of general insurance agent taka seventy five;
- (2) The licence fees specified in sub-rule (1) shall be paid by affixing in the application Government stamp called "বামা ফি ভাটালা" of equal amount of fee and the applicant shall put his signature on the face of the stamp.
- 18E. Grant of licence.—The Controller of Insurance or an officer authorised by him in this behalf shall, after taking all reasonable steps to satisfy himself that the application for temporary licence of life insurance agent, fresh temporary licence of life insurance agent, renewable licence of life insurance agent or licence of general insurance agent, as the case may be, is in order and the applicant is not disqualified from holding such licence under sub-section (12) of section 42 of the Act, issue—
 - (a) temporary licence of life insurance agent and fresh such licence in Form-VIC for a period of two years;
 - (b) renewable licence of life insurance agent in Form-VID for a period of three years;
 - (c) licence of general insurance agent in Form-VIE for a period of one year.
- 19. Renewal of licences.—(1) Licences of renewable licence of life insurance agent and general insurance agent, as the case may be, may, if he desires to renew his licence, apply to the licence issuing officer for renewal of his licence in Form-VII and Form-VIII respectively.
- (2) The following shall be fees of renewal of licence, namely:-
 - (a) renewal of life insurance agent licence taka seventy five;
 - (b) renewal of general insurance agent licence taka one hundred fifty.
- (3) The renewal fee under sub-rule (2) shall be paid in such manner as specified under rule-18D (2).
- 19A. Grant of renewal of licence.—(1) The licence issuing officer shall renew the licence of renewable licence of life insurance agent and licence of general insurance agent for a period of three years in each case if he is satisfied that—
 - (a) the application is in order;

- (b) the appiclation reached him at least one month before the date on which the licence ceases to remain in force;
- (c) in the case of life insurance, the applicant submits his certificate from the insurer concerned with effect that during the period of licence be procured new life insuarnce business assuring the sum of not less than 2 lac taka in each year, of which at least the first years due premium has been paid in full and of which at least 40% remain in force:
- (d) in the case of general insurance, the applicant submits his certificate from the insurer concerned with effect that during the period of licence he procure premium of not less than one lac taka;
- (c) where the application reached him before the expiry of the day on which the licence ceases to remain in force, an additional fee of taka five has been paid by way of penalty;
- (f) where the application reached him after the licence ceases to remain in force but the Controller of Insurance is further satisfied that undue hardship would be caused if the application is not entertained, an additional fee of taka thirty has been paid by way of penalty.
- 20. Temporary certificate of employer of agents of life insurance.—
 (1) Whoever worked as life insurance agent for at least 5 years and procured new life insurance business assuring a sum of not less than one lac taka in each year, of which at least the first year's due premium has been paid in full and of which 40% percent remain in force, may apply for temporary certificate of employer of agents of life insurance.
- (2) An application for temporary certificate under sub-rule (1) shall be made in Form IX.
- (3) The holder of a temporary certificate or any person who was at any time granted such certificate shall not be entitled to apply for fresh temporary certificate:

Provided that nothing in this sub-rule shall apply to a person who during the period when his certificate was in force introduced not less than 5 insurance agents subsequently qualified for renewable licence of life insurance and procured policy of at least 7½ lac taka of which at least fifty percent remain in force on the date of submitting application.

(4) The provisions of sub-rule (1) and (2) shall apply in the case of an application for another or fresh temporary certificate.

21. Renewable certificate of employer of agents of life insurance.-

- (1) Whoever holds a certificate on the date of commencement of this rule, which shall be deemed to be a temporary certificate within the meaning of rule 20(1), and whoever holds a temporary certificate of employer of agents of life insurance may, subject to his passing the examination referred to in rule 18B, apply to the Controller of Insurance for renewable certificate of employer of agents of life insurance.
- (2) An application for renewable certificate under sub-rule (1) shall be made in Form-IXA.
- 21A. Certificate for employer of agents of general insurance.—(1)

 Any person desiring to obtain a certificate of employer of agents of general insurance may apply to the Controller of Insurance for such certificate.
- (2) An application for certificate of employer of agents of general insurance shall be made in Form IXB.
- 21B. Fees for certificates.—(1) The following shall be the fees of certificates of employer of agents, namely:—
 - (a) temporary certificate of employer of agents of life insurance taka two hundred.
 - (b) fresh certificate of employer of agents of life inursance taka two hundred.
 - (c) renewable certificate of employer of agents of life insurance taka three hundred.
 - (d) certificate of employer of agents of general insurance taka two hundred.
- (2) The certificate fee under sub-rule (1) shall be paid in such manner as specified under rule 18D (2).
- 21C. Grant of Certificates.—(1) The Controller of Insurance of an officer authorised by him in this behalf shall, after taking all reasonable steps to satisfy that the application for temporary certificate, fresh temporary certificate, renewable certificate of employer of agents of life insurance or certificate of employer of agents of general insuarnce, as the case may be, is in order, issue—
 - (a) temporary certificate of employer of agents of life insurance and fresh such certificate in Form X for a period of two years;

- (b) renewable certificate of employer of agents of life insurance in Form XI for a period of three years;
- (c) certificate of employer of agents of general insurance in Form XII for a period of one year.
- 22. Renewal of certificates.—(1) The holder of renewable certificate of employer of agents of life insurance or the holder of certificate of employer of agents of general insurance may, if he desires to renew his certificate, apply to the certificate issuing officer for renewal of his certificate in Form XIII and Form XIIIA respectively.
 - (2) The following shall be fees of renewal of certificates, namely:-
 - (a) renewal of renewable certificate of employer of agents of life insurance taka two hundred.
 - (b) renewal of certificate of employer of agents of general insurance taka two hundred.
- (3) The renewal fee under sub-rule (2) shall be paid in such manner as specified under rule 18D(2).
- 22A. Grant of renewal of certificate.—(1) The certificate issuing officer shall renew a life insurance certificate for a period of three years and the general insurance certificate for a period of one year if he is satisfied that—
 - (a) the application for renewal is in order;
 - (b) the application reached him, in the case of life insurance ecrtificate, at least one month before the date on which the certificate ceases to remain in force and, in the case of general insurance certificate, before the date on which the certificate ceases to remain in force;
 - (c) in the case of application for life insurance, the applicant submits a certificate from the insurer concerned to the effect that during the period when his certificate was in force, he complied with all instruction relating to recruitment of agents and procured life issurance policy of at least taka seven and half lac of which at least forty percent remain in force on the date of submitting the application;
 - (d) in the case of application for general insurance if it reached him after the certificate ceases to remain in force but within twelve months from such ceasing an additional fee of taka two hundred has been paid by way of penalty.";

 - (2) The fee under sub-rule (1) of rule 27 for renewing a certificate to act as an insurance surveyor shall be fifty taka for each class of certificate.
 - (3) The additional fee by way of penalty, under sub-rule (3) of rule 27 payable with an application for renewal of a certificate to act as an insurance surveyor which reaches the Controller after the certificate ceases to remain in force shall be fifteen taka.
 - (4) The fee under sub-rule (1) of rule 30 for duplicate licence and duplicate certificate shall respectively be one taka and five taka.";
