৩। গত ২৬শে আগস্ট ১৯৭৯ ইং তারিখে দিবাগত রাতে অফিস কর্তব্য সম্পাদন করে মাননীয় মন্ত্রীর বাসা হতে নিজ বাসায় ফেরার পথে তিনি আততায়ীর হাতে নিম্নমভাবে নিহত হন। তিনি একনিষ্ঠ, কর্তব্যপরায়ণ, বিনয়ী এবং সদালাপী ছিলেন। মৃত্যুর পূর্বক্ষণ পর্যন্ত পরিপূর্ণ নিষ্ঠার সঙ্গে তিনি তাঁর দায়িত্ব পালন করে গেছেন।

৪। গণপ্রজাতন্ত্রী বাংলাদেশ সরকার তাঁর মৃত্যুতে আন্তরিক শোক প্রকাশ করছে এবং মরহুমের শোকসন্তপ্ত পরিবারের প্রতি গভীর সমবেদনা জ্ঞাপন করছে।
