NOTIFICATION

Dacca, the 11th August, 1977.

No. S.R.O. 246-L/77.—In exercise of the powers conferred by sub-section (1) of section 60 of the Income-Tax Act, 1922 (XI of 1922), the Government is pleased to exempt the expatriate personnel of the Asian-American Free Labour Institute (AAFLI), a non-profit voluntary organization incorporated in the United States of America working in Bangladesh under an AID contract to supervise programme and projects approved by the Government, from payment of income-tax under the said Act in respect of salary or other remuneration received or deemed to be received by or accruing or arising or deemed to accrue or arise in Bangladesh to such personnel.
