

No. S.R.O. 269-L/83/MFP/FD/A-6/CC-3/83.—In exercise of the powers conferred by Article 8 of the Bangladesh Coinage Order, 1972 (P. O. No. 83 of 1972), the Government is pleased to declare that the rupee coins issued under the authority of the Government of Pakistan before the 26th day of March, 1971, and thereafter issued under the authority of the Government of the People's Republic of Bangladesh shall cease to be legal tender in Bangladesh with effect from the 1st August, 1983.

These rupee coins shall, however, be received and exchange value paid across the counter at the offices of the Bangladesh Bank at Dhaka, Chittagong, Khulna, Bogra and Rajshahi and the Sonali Bank branches performing treasury functions up to 31st August, 1983 during banking hours.

No. S.R.O. 270-L-83/LVIII/1(9)/83.—In exercise of the powers conferred by section 16 of the Workmen's Compensation Act, 1923 (VIII of 1923) and in supersession of the Notification of the erstwhile Government of India in the Department of Industries and Labour, No. L-1189, dated the 28th March, 1935, the Government is pleased to direct that an annual return in the Form set forth in the Schedule hereto annexed shall be furnished by every person employing workmen.

- 2. The return, which shall relate to a calendar year, shall be furnished on or before the 1st February following the year to which the return relates, and the first return shall relate to the year 1983.
 - 3. The return shall be signed-
 - (a) by the employer or, where there is more than one employer, by any employer; or
 - (b) by any person directly responsible to the employer or employers for the management of the establishment to which it relates.
- 4. The return shall be furnished to the Commissioner with a copy to the Chief Inspector of Factories and Establishments.
