SUMMARY MARTIAL LAW COURT, CHITTAGONG

NOTIFICATIONS

Chittagong, the 18th October, 1978.

No. 2735-S.M.L.C.—Whereas it has been made to appear to this Court that accused (1) Mohammad Solaiman, son of late Nur Hossain, Vill. North Haliſahar, U.P. North Haliſahar, P. O. Ananda Bazar, P. S. Doublemoorings, district Chittagong, is required for the purpose of the trial in this Court in connection with S.M.L.C. Case No. 139/77, u/r. 14, M.L.R./75 ;

And whereas this Court has reason to believe that the said accused is absconding or concealing himself to avoid appearance or arrest for the aforesaid purpose ;

Now, therefore, in exercise of the powers conferred by Regulation 3(7) of M.L.R. 1/1975, the accused is hereby directed to appear before this Court at Court Building, Chittagong, on or before 4th December, 1978, failing which he will be tried *in absentia* and his properties may be confiscated.

Satkania, district Chittagong, is required for the purpose of the trial in this Court in connection with S.M.L.C. Case No. 448/77, u/r. 14, M.L.R./75 ;

And whereas this Court has reason to believe that the said accuseds are absconding or concealing themselves to avoid appearance or arrest for the aforesaid purpose ;

Now, therefore, in exercise of the powers conferred by Regulation 3(7) of M.L.R. 1/1975, the accuseds are hereby directed to appear before this Court at Court Buiding, Chittagong, on or before 4th December, 1978, failing which they will be tried *in absentia* and their properties may be confiscated.
