No. S.R.O. 273-L/79/501/Cus.—In exercise of the powers conferred by section 19 of the Customs Act, 1969 (IV of 1969), the Government is pleased to exempt all goods other than marble chips and marble powder falling within Heading No. 25·17 of the First Schedule to the Tariff Act, 1934 (XXXII of 1934), from the whole of customs duty leviable thereon.

This Notification shall be deemed to have come into force on and from the 2nd June, 1979.

No. S.R.O. 274-L/79/502/Cus.—In exercise of the powers conferred by clause (b) of section 21 of the Customs Act, 1969 (IV of 1969), and sub-section (3) of section 7 of the Sales Tax Act, 1951 (III of 1951), the National Board

of Revenue is pleased to direct that CKD parts of diesel engines and raw materials for manufacture of diesel engines imported by Bangladesh Diesel Plant, Joydevpur, Dacca under the Bangladesh Steel and Engineering Corporation shall be exempt from so much of customs-duty as is in excess of 15% ad valorem and from the whole of sales tax subject to the following conditions, namely :-

- 1. (a) The importer, before the clearance of the goods from the customs, shall make a declaration that the goods will be used for the manufacture of diesel engines at the Bangladesh Diesel Plant and shall execute a bond in such form as the Collector of Customs having jurisdiction may specify to the effect that these goods shall not be sold or used for any purpose other than manufacture of diesel engines at the Bangladesh Diesel Plant and shall also bind themselves to pay the amount of duty and taxes so exempted together with any fine or penalty that may be imposed by the Collector of Customs in this behalf in case the goods are used for any purpose other than for which these are imported,
 - (b) The importer shall maintain proper records and accounts of the imported CKD parts and raw material for verification by the Customs Authority at any time in order to satisfy itself that the parts and spares have actually been used in the manufacture of diesel engines.
- 2. This Notification shall be deemed to have come into force with effect from the 12th of July, 1979.

Amendments

In the aforesaid Order,-

- (1) In the first paragraph,-
 - (a) for the words "other than co-operative societies" the words "except co-operative societies" shall be substituted; and
 - (b) for the words and commas "formed by persons employed in any office of the Government or of any local authority or other authority, corporation or body established or constituted by the Government or" the words and commas "formed by persons, other than workers, employed in any office of the Government or of any corporation or other body corporate established or constituted" shall be substituted; and
- (2) after the second paragraph, the following explanation shall be added, namely:—

"Explanation.—For the purposes of this Order, the term "worker" shall have the same meaning as has been assigned to it in the Industrial Relations Ordinance, 1969 (XXIII of 1969)".
