NOTIFICATION

No. S.R.O. 278-L/77.—In exercise of the powers conferred by section 2 of the Emergency Powers Act, 1975 (Act I of 1975), the Government is pleased to make the following amendments in the Emergency Powers Rules, 1975, namely:—

Amendments .

In the said Rules,—

- (a) after rule 5, the following new sub-rules shall be inserted, namely;-
 - "5A. Communication of the grounds of detention order.—(1) In every case where an order of detention has been made under rule 5(1)(a), the Government shall, as soon as may be, but subject to the provisions of sub-rule (2), communicate to the person affected thereby the grounds on which the order has been made to enable him to make a representation in writing against the order, and shall also inform such person of his right of making such representation and afford him the earliest opportunity of doing so:

Provided that nothing in this rule shall require the Government to disclose facts which it considers to be against public interest to disclose.

(2) In the case of a detention order under rule 5(I)(a), Government shall inform the person detained of the grounds of his detention at the time he is detained or as soon thereafter as practicable, but not later than 15 days from the date of detention:

Provided that when a person has been already under detention being committed to custody under sub-rule (2) of rule 30, the Government shall inform the person detained of the grounds of his detention at the time the order under rule 5(1)(a) is made.

5B. Constitution of Advisory Committee (1) The Government shall, whenever necessary, constitute an Advisory Committee for the purpose of these rules.

- (2) The Advisory Committee shall consist of a Chairman who shall be a judge of the High Court and two other Members of whom one shall be a senior officer in the service of the Republic and the other a person who has, for not less than ten years, held judicial office in the territory of Bangladesh.
- (3) The Chairman and the Members shall be appointed by the Government.
- 5C. Reference to Advisory Committee.—(1) In every case where a detention order has been made under rule 5(1)(a), the Government shall, within one hundred and twenty days, from the date of detention place before the Advisory Committee constituted under rule 5B the grounds on which the order has been made and the representation, if any, made by the person affected by the order.
- 5D. Procedure of Advisory Committee,—(1) The Advisory Committee shall, after considering the materials placed before it and calling for such further information as it may deem necessary from the Government or from the person concerned and after affording the person concerned an opportunity of being heard in person, submit its report to the Government within one hundred and seventy days from the date of detention.
- (2) The report of the Advisory Committee shall specify in a separate part thereof the opinion of the Advisory Committee as to whether or not there is sufficient cause for detention of the person concerned.
- (3) Where there is a difference of opinion among the members of the Advisory Committee the opinion of the majority of such members shall be deemed to be the opinion of the Board.
- (4) Nothing in this rule shall entitle any person against whom a detention order has been made to appear by any legal practitioner in any matter connected with the reference to the Advisory Committee; and the proceeding of the Advisory Committee and its report, excepting that part of the report in which the opinion of the Advisory Committee is specified. shall be confidential.
- 5E. Action upon the Report of the Advisory Committee,—(1) In any case where the Advisory Committee has reported that there is, in its opinion sufficient cause for the detention of a person, the Government may confirm the detention order and cotinue the detention of the person for such period as it thinks fit:

Provided that the Advisory Committee shall, after affording the person concerned an opportunity of being heard in person, review such detention order, unless revoked earlier, once in every six months from the date of such detention and the Government shall inform the person concerned of the result of such review.

(2) In any case where the Advisory Committee has reported that there is, in its opinion, no sufficient cause for the detention of the person concerned the Government shall revoke the detention order and inform the person to be released forthwith.

- 5F. Revocation of detention Orders.—(1) A detention order may, at any time, be revoked or modified by the Government."; and
- (b) in sub-rule (1) of rule 30, after the words "Police Officer", the words "not below the rank of Sub-Inspector" shall be inserted.
