NOTIFICATION

Dhaka, the 7th July, 1986

No. S.R.O. 278-L/86/MVRT/1A-3/85.—The following draft of certain further amendments in the Motor Vehicles Rules, 1984, which it is proposed to make in exercise of the powers conferred by sections 22, 31 and 50 of the Motor Vehicles Ordinance, 1983 (LV of 1983), is hereby published as required under sub-section (1) of section 173 of the said Ordinance for information of all persons likely to be affected thereby and notice is hereby given that the draft will be taken into consideration on or after 23rd July, 1986.

Any objection or suggestion which may be received from any person with respect to the said draft before the date specified will be considered by the Government.

Draft Amendments

In exercise of the powers conferred by sections 22, 31 and 50 of the Motor Vehicles Ordinance, 1983 (LV of 1983), the Government is pleased to make the following further amendments in the Motor Vehicles Rules, 1984, namely :—

In the aforesaid Rules, in rule 6, for sub-rule (1), the following shall be substituted, namely :—

- (1) The Government shall constitute a driving competency test board for every metropolitan area and for every district to test the competence of candidate for a driving licence as per provision of the Third Schedule to the Ordinance consisting of the following members, namely :—

For the Metropolitan area

- (a) a magistrate of the first class to be nominated by *Chairman*, the Chief Metropolitan Magistrate.

- (b) Deputy Police Commissioner (Traffic)/Assistant Police Commissioner. *Member.*
- (c) an Assistant Professor of the Medical College situated in the area to be nominated by the Principal of the College concerned. *Member.*
- (d) a Mechanical or Automobile Sub-Divisional Engineer to be nominated by the Chief Engineer, Roads and Highways Department. *Member.*
- (e) an Instructor with expertise in motor driving of the Polytechnic Institute situated in the area to be nominated by the Principal of the Institute concerned. *Member.*
- (f) Motor Vehicle Inspector having jurisdiction of the area. *Member-Secretary.*

For the Districts

- (a) a Magistrate of the first class to be nominated by the Deputy Commissioner. *Chairman.*
- (b) a Deputy or Assistant Superintendent of Police to be nominated by the Superintendent of Police. *Member.*
- (c) a Medical Officer to be nominated by the Civil Surgeon of the district. *Member.*
- (d) Motor Vehicle Inspector having jurisdiction in the area. *Member-Secretary.*
