Ord. XIX of 1963), are essential for maintaining services necessary to the life of the community;

XLI of 1958), the Government is pleased to declare all classes of employment under the said Water Supply and Sewerage Authorities to be classes of employment to which the aforesaid Essential Services (Second) Ordinance, 1958, shall apply.
