উপরি-উক্ত Rules এর SCHEDULE-I (Allocation of Business among the different Ministries and Divisions) এর Serial No. 33 এর "MINISTRY OF POSTS, TELECOMMUNICATIONS AND INFORMATION TECHNOLOGY" শিরোনামাধীন "A. POSTS AND TELECOMMUNICATIONS DIVISION" উপ-শিরোনামার এন্ট্রিসমূহের পরিবর্তে নিম্নরূপ এন্ট্রিসমূহ প্রতিস্থাপিত হইবে, যথা :—

1. Formulation, implementation and revision of the Policies relating to Posts and Telecommunications and their applications.
2. Postal Facilities and Services.
3. Post Office Savings Banks and other approved banking activities.
4. Postal Life Insurance.
5. Mailing Operations and Courier Services.
6. Different Agency Services delivered through Postal Networks.

7. Telecommunications services including Telephony, Narrowband and Broadband Internet/Intranet, Data Communications and associated services at home and abroad.
8. Telecommunications Industries including Manufacturers, Suppliers and Service Providers.
9. Telecommunications related infrastructure development including Network Equipment, Access Networks, National and International Long Distance Data Transmission Networks, Communication Satellites and Satellite Ground Stations.
10. Over the Top application services using Telecommunications Networks.
11. Telecommunications resources including Radio Frequencies, Telephone Numbering, IP Addresses, Country Code Top Level Domains and Identification Numbers used in Telecommunications/Data Networks.
12. Matters relating to Safety and Security of the Telecommunications Networks and elements along with their usages/applications, Cyber Security.
13. Matters relating to investment in the Telecommunications sector.
14. Standards, Protocols, Procedures and Codes relating to Telecommunications sector.
15. Promote Research and Development (R & D), Human Resource Development and Entrepreneurship Development in the Posts and Telecommunications sector.
16. Matters relating to the State Owned Enterprises under this Division.
17. Administration of B.C.S (Postal) Cadre.
18. Administration of B.C.S (Telecommunication) Cadre.
19. Secretariat administration including financial matters and Human Resources Management of this Division.
20. Administration and control of the following Departments, Subordinate Offices and Organizations under this Division:
 - (a) Department of Posts,
 - (b) Department of Telecommunications (DoT),

- (c) Bangladesh Telecommunication Regulatory Commission (BTRC),
 - (d) Bangladesh Telecommunications Company Limited (BTCL),
 - (e) Bangladesh Submarine Cable Company Limited (BSCCL),
 - (f) Bangladesh Cable Shilpa Limited (BCSL),
 - (g) Telephone Shilpa Sangstha (TSS) Limited,
 - (h) Teletalk Bangladesh Limited,
 - (i) Bangladesh Communication Satellite Company Limited (BCSCL),
 - (j) Mailing Operator and Courier Service Licensing Authority.
