No. S.R.O. 292-L/78.—In exercise of the powers conferred by section 11 of the Bangladesh Travel Agencies (Registration and Control) Ordinance, 1977 (XLVIII of 1977), the Government is pleased to make the following further amendments in the Bangladesh Travel Agencies (Registration and Control) Rules, 1977, namely:—

In the aforesaid Rules,—

- (a) in rule 6, in sub-rule (3), for the word and letter "Form 'B'" at the end the word and letter "Form 'C'" shall be substituted;
- (b) in Form B,—
  - (i) in the heading, for the words and figures "Certificate/Renewal of Registration Certificate under rule 5/6" the words and figure "Certificate under rule 5" shall be substituted; and

- (ii) for the words "Registered/Renewed" the word "registered" shall be *substituted*; and
- (c) after Form B amended as aforesaid, the following new Form C shall be *added*, namely:—

**NOTIFICATION**

No. S.R.O. 293-4/78/S-VI/8(12)/78.—In exercise of the powers conferred by sub-section (I) of section 3 of the Shops and Establishments Act, 1965 (E. P. Act VII of 1965), the Government



is pleased to suspend the operation of the provisions of sections 4, 8, 10 and 11 of the said Act in respect of the establishments mentioned in the Schedule below for the period beginning on the 1st November 1978 and ending on the 30th April 1979 subject to the following conditions, namely:

- (a) the workers required to work overtime shall be paid wages at double the rate of ordinary wages for working beyond the normal working hours; and
- (b) the workers deprived of weekly holidays shall be allowed compensatory weekly holidays within a month after the 30th day of April 1979.

NOTIFICATION

Special M.L. Case No. 04/78, Chatkhil P.S. Case No. 04, dated 17th September 1977, Noakhali Sadar G.R. Case No. 774/77, u/s. 395/397, BPC.

Whereas it appears that the undermentioned accused persons are wanted in the Special Martial Law Court No. III, Comilla, in connection with the abovenoted Case;
