**G. R. Case No. 44/75 corresponding M. L. Case No. 65/77.**

**Rangamati, the 5th July 1978.**

Whereas it appears that accused Faridul Alam, son of Abdul Rashid, Nurul Alam, son of late Abdul Aziz and Abul Kashem, son of Fazal Ahmed, all of Gohira, P.S. Rauzan, district Chittagong, have been involved in Kotwali P.S. Case No. 13(2)75 and G.R. Case No. 44/75, u/s 6 of Act 1/1956 and they are required for the purpose of trial in the Summary Martial Law Court, Chittagong Hill Tracts;

And whereas this Summary Martial Law Court, Chittagong Hill Tracts, has reason to believe that the said Faridul Alam, Nurul Alam and Abul Kashem have been absconding or concealing their presence to avoid appearance or arrest for the said purpose;

Now, therefore, in exercise of the powers conferred by the Martial Law Regulation 3(7) of 1975, I, Md.
