required by clause (2) of Article 140 of that constitution, is pleased to make the following rules, namely :—

THE GAZETTED OFFICERS (TARIFF COMMISSION) RECRUITMENT RULES, 1978.

1. **Short title.**—These rules may be called the Gazetted Officers (Tariff Commission) Recruitment Rules, 1978.

2. **Definitions.**—In these rules, unless the context otherwise requires,—

- (a) "appointing authority" means the Government and includes in relation to any specified post or class of such posts, any officer authorised by the Government to make appointment to such posts or class of posts;
- (b) "Commission" means the Bangladesh Public Service Commission;
- (c) "Department" means the Tariff Commission;
- (d) "probationer" means a person appointed on probation to a specified post;
- (e) "recognised University" means a University established by or under any law for the time being in force and includes any other University declared by Government, after consultation with the Commission, to be a recognised University for the purpose of these rules;
- (f) "requisite qualification" means the qualification prescribed in the Schedule;
- (g) "Schedule" means the Schedule appended to these rules; and
- (h) "specified post" means a post specified in the Schedule.

3. **Procedure for recruitment.**—(1) Subject to the provisions of the Schedule and such instructions relating to reservation for the purposes of clause (3) of Article 29 of the Constitution of the People's Republic of Bangladesh, appointment to a specified post shall be made—

- (a) by promotion; or
- (b) by direct recruitment; or
- (c) by transfer of service on deputation.

(2) No person shall be appointed to a specified post unless he has the requisite qualification and in the case of direct recruitment he is also within the age limit laid down in the Schedule for that post.

4. **Appointment by direct recruitment.**—(1) No appointment to a specified post by direct recruitment shall be made except upon the recommendation of the Commission.

(2) No person shall be eligible for appointment to a specified post by direct recruitment, if he—

- (a) is not a citizen of Bangladesh, or a permanent resident of, or domiciled in, Bangladesh;
- (b) is married to, or has entered into a promise of marriage with, a person who is not a citizen of Bangladesh.

(3) No appointment to a specified post by direct recruitment shall be made until—

- (a) the person selected for appointment is certified by a Medical Board set up for the purpose by the Director of Health Services to be medically fit for such appointment and that he does not suffer from any such organic defect as is likely to interfere with the discharge of the duties of the specified post; and
- (b) the antecedents of the persons so selected have been verified through appropriate agencies and found to be such as do not render him unfit for appointment in the service of the Republic.

(4) No person shall be recommended for appointment to a specified post, unless—

- (a) he applied in such form, accompanied by such fee and before such date, as was notified by the Commission while inviting applications for the specified post; and
- (b) in the case of a person already in the Service of the Republic or in the service of a local authority, he applied through his official superior.

5. Appointment by promotion or transfer of service on deputation.—
Appointment by promotion or transfer of service on deputation to a specified post shall be made on the recommendation of the Departmental Selection Committee or, in such cases as the Government decides in this behalf, the Commission:

Provided that Chairman and Secretary shall be appointed on a tenure basis for a maximum period of three years which may be extended for a further period of two years or such shorter period as the Government may think fit.

6. Probation.—(1) Persons selected for appointment to a specified post otherwis^u than by transfer of service on deputation against a substantive vacancy shall be appointed on probation—

- (a) in the case of direct recruitment, for a period of two years from the date of substantive appointment; and
- (b) in the case of promotion for a period of one year from the date of such appointment :

Provided that the appointing authority may, for reason to be recorded in writing, extend the period of probation by a period or periods so that the extended period does not exceed two years in the aggregate.

(2) After completion of the probation period including the extended period, if any, the appointing authority—

- (a) if it is satisfied that the conduct and work of the probationer during his period of probation have been satisfactory, shall, subject to the provisions of sub-rule (3), confirm him; and

(b) if it is of the opinion that the conduct and work of the probationer during that period were not satisfactory, shall, in the case of direct recruitment terminate his service and in the case of promotion revert him to the post from which he was promoted.

Explanation.—The period of probation of a probationer shall be deemed to have been extended if no order has been made under this rule.

(3) A probationer shall not be confirmed in a specified post until he has passed such examination and training as the Government may, from time to time, direct.
