2. The functions of the Committee will be to consider all proposals of procurement & purchases by Ministries/Divisions, etc., costing above Taka 10 (ten) crores.

3. The following officials may aid and assist the Council Committee :—

(2) One Brigadier from Armed Forces;

(3) One Joint Secretary, Ministry of Home Affairs; and

(4) One Joint Secretary, Cabinet Division.

NOTIFICATION

Dacca, the 24th November, 1978.

No. S.R.O. 309-L/78.—In exercise of the powers conferred by the proviso to article 133 of the Constitution of the People's Republic of Bangladesh, the President, after consultation with the Bangladesh Public Service Commission, as required by clause (2) of article 140 of that Constitution, is pleased to make the following further amendment in the Superior Posts (Examination for Recruitment) Rules, 1976, namely:—

In the aforesaid Rules, in rule 12, for sub-rule (3) the following shall be substituted, namely:—

“(3) Notwithstanding the provisions of sub-rules (1) and (2), the maximum age limit,—

(a) in the case of the first examination under these rules shall, for all candidates, be 30 years on the 1st day of September, 1976; and

- (b) in the case of the second examination under these rules, shall,—
- (i) for candidates who are freedom fighters, be 30 years, and
 - (ii) for candidates other than freedom fighters, be 28 years,
- on the 1st day of September, 1978.”.

No. S.R.O. 310-L/78/CA-1(49)/Esstt./78.—The following draft of certain further amendments to the Aircraft Rules, 1937, which it is proposed to make in exercise of the powers conferred by section 5 of the Civil Aviation Ordinance, 1960 (XXXII of 1960), is hereby published as required by sub-section (2) of section 15 of the said Ordinance for the information of all persons likely to be affected thereby, and notice is hereby given that the draft will be taken into consideration after a period of three months from the date of its publication in the official Gazette.

Any objection or suggestion which may be received from any person with respect to the said draft before the expiry of the aforesaid period will be considered by the Government:

Draft Amendment

In the aforesaid Rules, in rule 144,—

- (a) in sub-rule (1), for the letters and figure “Rs. 500” the word and figure “Taka 3000” shall be *substituted*; and
- (b) in sub-rule (2), for the letters and figure “Rs. 150” the word and figure “Taka 500” shall be *substituted*.

IN THE SUMMARY MARTIAL LAW COURT, KUSHTIA

SGR Case No. 143/78,

STATE

versus

SHADHU *alias* Md. SAIDUL HAQUE AND ANOTHER.

Whereas it has been made to appear to the Court that accused Shadhu *alias* Md. Saidul Haque, son of Md. Lutful Haque of Carew's E type quarter, Darsana, (2) Ramizuddin (R.P.), son of Bahauddin of Darsana Amtalapara, both of

P.S. Damurhuda, Dist. Kushtia, are required for the purpose of trial in the Summary Martial Law Court, Kushtia, u/s 19, MLR. in connection with the abovenoted G.R. Case in Damurhuda P.S. Case No. 10, dated 13th October 1978;

And whereas this Court has reason to believe that the said accused persons are absconding or concealing themselves to avoid appearance or arrest for the said purpose;

Now, therefore, in exercise of powers conferred upon me by MLR No. 3(7)/76, I do hereby direct the said accused persons to be seated at Chuadanga on or before 29th November 1978, failing which they will be tried *in absentia* and their properties may be forfeited to the Government.
