NATIONAL BOARD OF REVENUE

(Income-tax)

NOTIFICATION

Dacca, the 16th September 1981

No. S.R.O. 317-L/81.—The following draft of certain further amendments in the Income-tax Rules, which the National Board of Revenue proposes to make in exercise of the powers conferred by section 59 of the Income-tax Act, 1922 (XI of 1922), is hereby published as required by sub-section (4) of the said section, for the information of all persons likely to be affected thereby, and notice is hereby given that the said draft will be taken into consideration on or after the 20th October, 1981. Any objection or suggestion which may be received from any person in respect of the said draft before the specified date will be considered by the Board.

Draft Amendment

In the aforesaid Rules, in rule 39, in sub-rule (1), in the Schedule,-

(a) for serial Nos. 1 and 2 the following shall be substituted, namely:—

- "1. Where house rent allowance is receivable by the assessee in cash-
 - (a) Where the allowance does not exceed Taka 1800 per month or 50 per cent of the basic salary of the assessee, whichever is the less

(b) In other cases—

The amount, if any, by which such allowance exceeds Taka 1800 per month or 50 per cent of the basic salary of the assessee, whichever is the less.

- 2. Where rent-free accommodation is provided-
 - (a) Where the accommodation is unfurnished

The rental value of the accommodation or 15 per cent of the basic salary of the assessee, whichever is the less.

(b) Where the accommodation is furnished-

> The rental value of the accommodation or 20 per cent of the basic salary of the assessee whichever is the less.";

- (b) in serial No. 4,-
 - (i) in item (b) (ii), for the letters and figure "Rs. 3000" occurring twice the word and figure "Taka 3600" shall be substituted in both places;
 - (ii) in item (b) (iii), for the letters and figure "Rs. 2400" occurring twice the word and figure "Taka 3000" shall be substituted in both the places;
 - (iii) in item (b) (iv), for the letters and figure "Rs. 900" "occurring twice the word and figure "Taka 1200" shall be substituted in both the places:
 - (iv) in item (c) (iii), for the letters and figure "Rs. 3000" occurring twice the word and figure "Taka 3600" shall be substituted in both the places; and
 - (v) in item (c) (iv), for the letters and figure "Rs. 2400" occurring twice the word and figure "Taka 3000" shall be substituted in both the places.

The proposed amendments shall have effect in respect of an assessment for any year beginning on the 1st day of July, 1981 and thereafter.
