No. 924-Pub.—The following Ordinance made by the President of the People's Republic of Bangladesh, on the 15th September, 1976, is hereby published for general information:—

THE STATE-OWNED MANUFACTURING INDUSTRIES WORKERS (TERMS AND CONDITIONS OF SERVICE) (AMENDMENT) ORDINANCE, 1976.

Ordinance No. LXX of 1976.

AN ORDINANCE

to amend the State-owned Manufacturing Industries Workers (Terms and Conditions of Service) Act, 1974.

Whereas it is expedient to amend the State-owned Manufacturing Industries Workers (Terms and Conditions of Service) Act, 1974 (X of 1974), for the purpose hereinafter appearing;

Now, Therefore, in pursuance of the Proclamations of the 20th August, 1975, and the 8th November, 1975, and in exercise of all powers enabling him in that behalf, the President is pleased to make and promulgate the following Ordinance:—

Short title.—This Ordinance may be called the State-owned Manufacturing Industries Workers (Terms and Conditions of Service) (Amendment) Ordinance, 1976.

- Amendment of section 3, Act X of 1974.—In State-owned Manufacturing Industries Workers (Terms and Conditions of Service) Act, 1974 (X of 1974), in section 3, for sub-section (2) the following shall be substituted, namely:
 - "(2) A notification under sub-section (1), or amendment of any such notification to withdraw, reduce or otherwise vary the benefits determined thereby, may be so issued as to have retrospective effect."
