No. S.R.O. 321-L/77/383/D/Cus.—In exercise of the powers conferred by section 19 of the Customs Act, 1969 (IV of 1969), the Government is pleased to make the following further amendment in this Ministry's notification No. S.R.O. 30/D/Cus/72, dated the 30th June, 1972, namely:—

In the aforesaid Notification, in the Table, for Heading No. 63.01 in column (1) and the entries relating thereto in columns (2) and (3) the following shall be substituted, namely:—

“63.01 (a) Clothing and clothing accessories:—

(i) of wool or synthetic wool .. .. . 40% *ad val.*

(ii) other than of wool or synthetic wool .. .. . 75% *ad val.*

(b) travelling rugs and blankets made of wool or synthetic wool. 50% *ad val.*”.

2. This Notification shall be deemed to have taken effect on and from the 25th June, 1977.
