PUBLIC NOTICE NO. 72(75)/IMPORT

Dacca, the 4th September 1975.

In continuation of this office Public Notice No. 57(75)/Import, dated 21st July 1975, it is hereby notified for information of the eligible commercial importers of dyes and chemicals, all sorts including soda ash, insecticides, pesticides, creosote oil, sodium sulphide, pigments and dry colours, that they may now import the aforesaid item/items either from Bangladesh-Czechoslovak Barter No. 3 or from Bangladesh-Bulgaria Barter No. 3 in accordance with the basis of licensing already announced.

- 2. Under no circumstances shall an importer open letters of credit for an amount exceeding the basis of licensing (i.e., Tk, 7,000 each) in all. Importers will open letters of credit direct through their nominated banks and it will not be necessary to present licence form and obtain licences in the usual manner.
- 3. The nominated banks of the commercial importers concerned shall, after due verification of the eligibility of the importer and his share, forward letters of credit application to the designated bank, i.e., Sonali Bank, Dacca in case of Bangladesh-Czechoslovak Barter No. 3 and Uttara Bank, Dacca in case of Bangladesh-Bulgaria Barter No. 3, after endorsing the Pass Book of the importer concerned and under intimation to the Licensing Authority concerned. The designated bank will open letters of credit under intimation to the Chief Controller of Imports and Exports, Dacca.
- 4. In case of multi-item holder commercial importers, under the current Import Policy they are permitted to import only one item of their choice from amongst those included in List-I of the Import Policy (July—December, 1975)

Order. In case such an importer opts to import any of the items listed in paragraph I of Public Notice No. 57(75)/Import, dated 21st July 1975, then he shall neither apply for nor obtain licence for any other item permissible for import under list I of the said Order during the current shipping period. Any violation of this provision in any manner may result in cancellation of Import Registration.

5. Application for opening letters of credit under Bangladesh-Bulgaria Barter No. 3 should reach the designated bank (Uttara Bank) on or before 20th December 1975 and the letters of credit so established will remain valid for shipment up to 30th June 1976. The dates for submission of application for opening letters of credit and shipment in respect of Bangladesh-Czechoslovak Barter No. 3 shall remain the same as notified in this Office Public Notice No. 57(75)/Import, dated 21st July 1975.

In partial modification of this Public Notice No. 70(75)/Import, dated - 1st September 1975, it is hereby notified for infomation of all concerned that the flast date for shipment of goods under IDA Credit No. 515-BD, is 31st January 1976 and not 31st March 1976.
