

#### Dacca, the 14th September 1982

No. S.R.O. 330-L/82/MVRT/3M-38/82.—The following draft of certain further amendments to the Motor Vehicles Rules, 1940, which it is proposed to make, in exercise of the powers conferred by sections 21, 41 and 68 of the Motor Vehicles Act, 1939 (IV of 1939), is hereby published as required by sub-section (1) of section 133 of the said Act for the information of all persons likely to be affected thereby and notice is hereby given that the draft will be taken into consideration on or after 19th September 1982.

Any objection or suggestion which may be received from any person with respect to the said draft before the date specified will be considered by the Government:

#### Draft Amendments

In the aforesaid Rules,-

- (a) in rule 3.—
  - (i) in clause (a), for the words "the Dacca" the word "a" shall be substituted;
  - (ii) in clause (b), for the words "Deputy Commissioner" the words "Superintendent of Police" shall be substituted;

- (b) in rule 29 .--
  - (i) in clause (i), for the words "the Dacca" the word "a" shall be substituted;
  - (ii) in clause (ii), for the words "Deputy Commissioner" the words "Superintendent of Police" shall be substituted.
