IN THE SUMMARY MARTIAL LAW COURT AT RAJSHAHI PROCLAMATION

Whereas it has been made to appear to me that Mr S. M. Mohid, General Assistant and Store Keeper, Thana Population Control and Family Planning Office, Godagari, son of S. M. A. Wahid, Satellite Town Quarter No. A.167, P.S. Paba, district Rajshahi, is required for the purpose of trial in the Summary Martial Law Court at Rajshahi under Regulation 11 M.L.R.;

And whereas this Court has reason to believe that the accused (1) Mr. S. M. Mohid, General, Assistant and Store Keeper, Thana Population Control and Family Planning Office, Godagari, son of S. M. A. Wahid, Satellite Town Quarter No. A.167, P.S. Paba, district Rajshahi, is absconding himself to avoid appearance or arrest for the purpose;

Now, therefore, in exercise of the powers conferred by Martial Law Regulation 3(7) of Martial Law Regulation No. I of 1975 this Summary Martial Law Court at Rajshahi do hereby direct—

(1) Mr S. M. Mohid, General Assistant and Store Keeper, Thana Population Control and Family Planning Office, Godagari, son of S. M. A. Wahid, Satellite Town Quarter No. A.167, P.S. Paba, district Rajshahi, to appear in this Court at Rajshahi on the 26th day of November, 1977 at 10-00 a.m. in the Martial Law G.R. Case No. 1405/76, failing which he will be tried *in absentia* and his property may be forfeited to the Government.
