No. S. R. O. 333-L/75/257/Cus/75.—In exercise of the powers conferred by section 19 of the Customs Act, 1969 (IV of 1969), and in partial modification of the Ministry of Finance Notification No. S. R. O. 80-L/75/212/D/Cus/75, dated the 12th February 1975, the Government is pleased to exempt the goods mentioned in the Table below, imported into Bangladesh out of the earnings of the nationals of Bangladesh abroad and shipped after the 9th day of January, 1975 from the whole of the customs-duties leviable thereon, subject to the condition of the goods being consigned to a recognised commercial importer holding valid import registration certificate issued by the Controller of Imports and Exports:—

No. S.R.O. 334-L/75/258/Cus/75.—In exercise of the powers conferred by section 19 of the Customs Act, 1969 (IV of 1969), and section 7 of the Sales Tax Act, 1951 (III of 1951), the Government is pleased to exempt dates and dried grapes falling under Heading Numbers 08-01 and 08-04 respectively of the First Schedule to the Tariff Act, 1934 (XXXII of 1934), and imported between the 8th of September, 1975 and the 8th of October, 1975 from the whole of the customs-duties and sales tax leviable thereon. For this purpose, the dates of importation shall mean the date of the submission of the Bill of Entry.
