For direct recruitment: Class Master's degree or 2nd Class Master's degree with 2nd Class honours in Bio-chemistry or Pharmaceutical Chemistry or Pharmacy or Organic Chemistry or Veterinary Science (Pharmacology or Microbiology) or Applied Chemistry from a recognised University. OR

Bachelor of Science from a recognised University with 5 years' experience as Inspector of Drugs in the Department.
