No. S.R.O. 345-L/83/110-Excise.—In exercise of the powers conferred by sub-section (1) of section 12A of the Excises and Salt Act, 1944 (I of 1944), the Government is pleased to make the following further amendment in this Division's Notification No. S.R.O. 225-L/83/94-Excise, dated the 30th June, 1983, namely:—

In the aforesaid Notification, in Table II, in item No. 13.03 in column 1 for entries (c) and (d) in column 2 and the entries relating thereto in column 3, the following shall be substituted, namely:—

"(c) when the charge for admission to an entertainment of a filmshow provided by a cinema house is below taka one.

Nil.

(d) when the charge for admission to an entertainment of a film-show provided by a cinema house is taka one or more.

one hundred per cent. of such charges."

2. This Notification shall take effect on and from the 1st October, 1983.
