 - (iii) Deputy Inspector-General of Police, Special Branch, Dhaka; and
 - (b) in the case of a newspaper printed outside Dhaka-
 - (i) Director, Department of Films and Publications, 112, Circuit House Road, Dhaka;

- (ii) Deputy Commissioner of the district within the local limits of which the newspaper is printed; and
- (iii) Superintendent of Police, Special Branch of the district within the local limits of which the newspaper is printed.
