

ORDER

Dacca, the 13th December 1977.

No. S.R.O. 360-L/77/T-I/157/77/D-9/418.—In exercise of the powers conferred by section 7 of the Cantonments (Requisitioning of Immovable Property) Ordinance, 1948 (Ordinance No. IV of 1948), the Government is pleased to direct that the Military Estate Officer, Dacca Circle at Dacca, shall exercise all or any of the powers conferred or any duty imposed on the Government by sections 2,3,5 and 6 of the said Ordinance (excepting the powers to issue general orders regarding procedure) in respect of the Cantonments situated at Dacca, Ghazipur, Savar, Jessore and Tangail.

Whereas, on the report of the police, it appears to me that Mr Ajiruddin, son of Dorasot Ullah, village Raizraddah, P. S. Balagonj, district Sylhet is required for the purpose of trial under an offence punishable under M.L.R. 10/M.L. 19 of 1975.;
