No. S. R. O. 365-L/77.—In exercise of the powers conferred by F R. 45 of the Fundamental Rules, the Government is pleased to make the following amendments in the Bangladesh Allocation Rules, 1976, namely:—

In the aforesaid Rules, in rule 16-

- (a) for sub-rule (1) the following shall be substituted, nam.ly:—
 - "(1) In the event of death of an allottee, the accommodation shall be normally vacated by the widow of the allottee on the expiry of 'Iddit' period. If the deceased allottee leaves behind children having no house of their own and no sufficient sources of income, they may, on application, be allowed by the Government to retain accommodation up to one year from the date of the death of the deceased allottee"; and
- (b) in sub-rule (3),—
 - (i) for the words, figures and brackets "sub-rules (1) and (2)" the word, figure and brackets "sub-rule (2)" shall be substituted; and
 - (ii) the word and comma "death," shall be omitted.

Whereas, on the report of the police, it appears to me that Mr Khonda-kar Motaharul Islam, son of Mosharaf Hossain, village Atpara, P. S. Alamdanga, district Kushtia, is required for the purpose of trial under an offence punishable under MLR 10/ML 19 of 1975;

And whereas I have reason to believe that the said Mr Khondakar Motaharul Islam, son of Mosharaf Hossain of Atpara, P. S. Alamdanga, district Kushtia, is absconding or concealing himself to avoid arrest;

Now, therefore, in the exercise of the powers conferred upon me under MLR 3(7) of 1975, I, M. Ashraf Magistrate, 1st class and Member, Summary Martial Law Court, Sylhet do hereby direct the said Mr. Khandakar Motaharul Islam to appear before the unmary Martial Law Court, Sylhet by 16th January 1978 otherwise, the case against him shall be tried in absentia and the properties shall be forfeited to the State standing in the name of M. Now, therefore, in exercise of the powers vested in me under Regulation 3'7) of M. L. R. 1/75, I, Quazi Bashiruddin, Chairman, Special Martial Law Court No. V, Rangpur, do hereby direct the aforesaid accused persons to appear before me in my Court within 7 (seven) days from the date of its publication,

It is further ordered that if the said accused persons fail to comply with the above direction, they would be tried in their absence and their properties would be liable to be forfeited to the Government.
