Terms of Reference:

- (i) To examine and review the practice and procedure laid down in the Public Works Codes and similar other construction manuals for the execution of Public Works and recommend measures for streamlining and improving the same.
- (ii) To examine the necessity of advance purchase of stores and construction materials and recommend measures so that the practice can be discontinued in order to avoid piling up of stock suspense without affecting speed and quality of work.
- (iii) To examine the desirability of requiring the Public Works Department to participate in competitive bidding for the award of works to them by the various Government agencies.
- (iv) To recommend such other measures as may appear to it relevant and necessary.
- 2. The Committee will submit its report by the 30th November 1982.

No. S.R.O. 378-L/82.-In exercise of the powers conferred by section 104 of the Waqfs Ordinance, 1962 (E.P. Ord. I of 1962) read with sections 8, 14 and 16 thereof the Government is pleased to make the following rules, namely:-

- 1. Short title,-These rules may be called the Administrator of Wagfs Bangladesh Gratuity Rules, 1982.
- 2. Definitions,-In these rules, unless there is anything repugnant in the subject or context,-
 - (a) "completed year" means 12 months' continuous service with the Administrator of Waqfs, Bangladesh from the date of joining:

- (b) "employee" means the Administrator, Deputy Administrator, Assistant Administrator and other officers and servants of the Administrator of Waqfs, Bangladesh other than the following;—
 - (i) a Government servant on deputation; and
 - (ii) a re-employed retired Government servant who enjoys pensionary benefits from the Government;
- (c) "Form" means a Form appended to these rules;
- (d) "Pay" means the monthly pay earned by an employee during a calendar month for a post held by him substantively to which he is entitled by reason of his position and includes special pay and personal pay; and
- (e) "service" means continuous and full-time service with the Administrator of Waqfs, Bangladesh and includes probationary period followed by confirmation and authorised leave, except leave without pay, and period spent on authorised duty, courses of instruction or training in and outside Bangladesh.
- 3. Application.—These rules shall apply to the Administrator, Deputy Administrator, Assistant Administrator and every other officer and servant serving under the Administrator of Waqfs, Bangladesh.
- 4. Eligibility.—Every employee who leaves the service on completion of 10 years' continuous service or on attaining the age of superannuation, or dies or becomes disabled by accident during his service, or whose service is terminated by the appointing authority after 5 years' service other than as a disciplinary measure, shall be paid gratuity at the rate specified in rule 5.
- 5. Scale of gratuity.—The amount of gratuity shall be computed at the rate of one month's pay for each completed year of service or for any part thereof in excess of 180 days, subject to a maximum of Taka 25,000 or an amount equivalent to thirty months' pay of the employee, whichever is less. The pay last drawn shall be the basis for such computation.
- 6. Payment.—(1) Gratuity shall be paid at the time of finally leaving the service.
- (2) In the event of death of an employe before payment of gratuity, such payment shall be made to his nominee and, in the absence of his nominee, to his legal heir (s).
- 7. Nomination.—(1) Each employee shall make a nomination in Form 'A' conferring on one or more persons the right to receive the amount of gratuity in the event of his death before payment thereof.
- (2) An employee shall, in his nomination, indicate the share of gratuity to be paid to each nominee if he nominates more than one person under sub-rule (1).
- (3) A nomination made under sub-rule (1) may, at any time, be cancelled and fresh nomination may be made by an employee by a written notice in Form 'B'.
