## NOTIFICATION

Dhaka, the 15th November 1982

**No. S.R.O. 383-L/82/LMVIII/1(15)/82.**—The following draft of certain further amendments in the Payment of Wages Rules, 1937, which the Government proposes to make in exercise of the powers conferred by sub-section (2) of section 26 of the Payment of Wages Act, 1936 (IV of 1936), is hereby published as required by sub-section (5) of the said section for information of all persons likely to be affected thereby, and notice is hereby given that the draft will be taken into consideration on or after the 25th February 1983. Any objection or suggestion with respect to the said draft which may be received by the undersigned before the date specified will be duly considered by the Government:

## Draft Amendment

In the aforesaid Rules,—

- (1) throughout the Rules, unless otherwise provided,—
  - (a) the word "Bengal" and the letter and word "E. Bengal" shall be *omitted*;
  - (b) *for* the word "rupees" or "Rupees" or the letters "Rs." the word "Taka" shall be *substituted*; and
  - (c) *for* the words "Local Government" the word "Government" shall be *substituted*;
- (2) in rule 2, *for* clause (c), the following shall be *substituted*, namely :—
 

“(c) ‘the Chief Inspector of Factories’ means the Chief Inspector appointed under sub-section (1) of section 9 of the Factories Act, 1965 (IV of 1965);”;
- (3) in rule 6, *for* the words "the English language" the word "Bengali" shall be *substituted*;
- (4) in rule 7, in sub-rule (2), *for* the words, commas, figures and brackets "the Weights and Measures of Capacity Act, 1871 (XXXI of 1871), or the Pakistan Penal Code (XLV of 1860)" the words, commas, figures and brackets "the Standards of Weights and Measures Ordinance, 1982 (XII of 1982), or the Penal Code (Act XLV of 1860)" shall be *substituted*;
- (5) in rule 8, *for* the words "English and in the language of majority of the persons employed therein" the word "Bengali" shall be *substituted*;
- (6) in rule 10, in clause (a), *for* the word "English" the word "Bengali" shall be *substituted*;
- (7) in rule 12, *for* the words and commas "English, together with a literal translation thereof, in the language of the majority of the persons employed therein," the word "Bengali" shall be *substituted*;

- (8) in rule 16, in sub-rule (2), in clause (b), *for* the words "English and in the language of the majority of the employed persons" the word "Bengali" shall be *substituted*;
- (9) in rule 19, in sub-rule (2), in clause (c), *for* the letters and figures "Rs. 10", "Rs. 5" and "Rs. 30" the words "Taka forty" "Taka twenty" and "Taka sixty" shall respectively be *substituted*;
- (10) in rule 21,—
  - (a) in clause (i), *for* the words "One Rupee" the words "Four Taka" shall be *substituted*;
  - (b) in clause (ii),—
    - (i) in sub-clause (a), *for* the words "Eight annas" the words "Two Taka" shall be *substituted*; and
    - (ii) in sub-clause (b), *for* the words "Four annas" the words "One Taka" shall be *substituted*;
  - (c) in clause (iii), *for* the words "Eight annas" the words "Two Taka" shall be *substituted*;
  - (d) in clause (iv), *for* the words "Four annas for each member of the group subject to a maximum of five rupees" the words "One Taka for each member of the group subject to a maximum of twenty Taka" shall be *substituted*; and
  - (e) in clause (v), *for* the words "Five Rupees" the words "Twenty Taka" shall be *substituted*;
- (11) *for* FORM I, FORMS II and III, the following shall be *substituted*, namely :—

- "1. The Act applies to the payment of wages payable to any person including an apprentice employed in this factory to do any skilled, unskilled, manual, technical, trade promotional or clerical work for hire or reward, but does not include any such person—
- (a) who is employed in a managerial or administrative capacity; or
  - (b) who, being employed in a supervisory capacity, performs functions of managerial or administrative nature.";
- (b) in paragraph 3, in clause (a), for the words "President or the Local Government" the word "Government" shall be substituted;
- (c) in paragraph 9, in sub-paragraph (2), in clause (a), for the words "half-an-anna in the rupee" the words "ten poisha in the taka" shall be substituted;
- (d) in paragraph 19, for the brackets and words "(in Dacca to the Court of Small Causes) to the District Court" the words "Labour Appellate Tribunal" shall be substituted; and
- (e) for paragraph 20, the following shall be substituted, namely:—

Any one delaying the payment of wages beyond the due date, or making any unauthorised deduction from wages is liable to a fine up to Taka 500, or simple imprisonment up to six months, or both; but only the authority or the Labour Appellate Tribunal, as the case may be, shall take cognizance of the offence upon a complaint of facts constituting such offence."
