

No. S.R.O. 387-L/82.—In exercise of the powers conferred by sub-section (3) of section 13A and sub-section (1) of section 14 of the Jute Ordinance, 1962 (LXXIV of 1962), the Government is pleased to direct that every exporter of raw jute specified in the Schedule below shall purchase loose jute to the extent of at least 10,000 maunds, 6,000 maunds and 4,000 maunds during the months of November, 1982, December, 1982 and January, 1983, respectively, 50% of the quantity for each month being purchased at his agencies operating outside the terminal markets and his main station of business, and every such exporter shall furnish a fortnightly report in the Form appended below on the progress of his purchase, so as to reach the Directorate of Jute, 99, Motijheel C/A, Dhaka-2, within 7 days of the expiry of each fortnight.
