নং এস, আর, ও ৩৯২-আইন/৮৯ শা-২/এম-৪১/৮৭/৯৯৩—Water Supply and Sewerage Authority Ordinance, 1963 (E. P. Ord. XIX of 1963), এর section 52 এবং section 19 এর সহিত পঠিতব্য ক্ষমতাবলে সরকার Dhaka/Chittagong Water Supply and Sewerage Authority (Water Connection and Levy of water Rate) Rules, 1966 এ নিম্নরূপ অধিকতর সংশোধন করিল, যথা :—

উপরি-উক্ত Rules এর rule 24 এর পর নিম্নরূপ rule 24A গঠিত হইবে, যথা :—

“24A, Grant of permission under section 21A of the Ordinance. :—

(1) The Authority shall grant, if applied for, permission in a form to be specified by it to any person for the construction and maintenance of facilities mentioned under sub-section (1) of section

21A of the Ordinance on payment of the charges at the following rates, namely:—

(2) The permission granted under sub-rule (1) shall remain valid for a period of one year from the date of issuance of the permission and may be renewed from year to year on payment of the renewal charges at the following rates, namely:—

(3) If any person wants to continue the facilities in existence as mentioned in the proviso to sub-section (2) of the aforesaid section beyond the period of six months as specified in the said proviso, he shall apply to the Authority in the form specified by it for permission to continue such facilities on payment of charges which shall be equal to renewal charge specified in sub-rule (2).

(4) If a person permitted under sub-rules (1) and (3) to get their permission renewed even if the Authority is capable of supplying water from its own supply network, he shall have to pay an additional charge at the rate of 25% in excess of the normal renewal charges.

(5) Notwithstanding the provision under sub-rule (4), the Authority may cancel such permission granted under that sub-rule if it is considered expedient in the public interest."
