NOTIFICATION

Dacca, the 14th August 1976.

No. S.R.O. 399-L/76/PP-I/IC-4 76 404.—In exercise of the powers conferred by the proviso to article 133 of the Constitution of the People's Republic of Bangladesh, the President, after consultation with the Bangladesh Public Service (First) Commission as required by clause (2) of article 140 of that constitution, is pleased to make the following rules, namely:—

1. **Short title.**—These rules may be called the Gazetted Officers (Directorate of Population Control and Family Planning) Recruitment Rules, 1976.

2. **Definitions.**—In these rules, unless there is anything repugnant in the subject or context,—

(a) “appointing authority” means the Government and includes, in relation to any specified post or class of such posts, any officer authorised by the Government to make appointment to such post or class of posts;

(b) “Commission” means the Bangladesh Public Service (First) Commission;

(c) “requisite qualification” in relation to a specified post means the qualification specified in column 5 of the schedule in relation to that post;

- (d) "Schedule" means the Schedule annexed to these rules; and
- (e) "Specified post" means a post specified in the Schedule.

3. Procedure of recruitment.—(1) Subject to the provisions of the Schedules appointment to a specified post shall be made—

- (a) by absorption;
- (b) by promotion from amongst persons holding specified posts;
- (c) by transfer on deputation; and
- (d) by direct recruitment.

(2) In the case of direct recruitment, no person shall be appointed to a specified post unless he has the requisite qualification and is also within the age limit, if any, laid down in the Schedule for that post:

Provided that in the case of a person who is already in the service of the Republic, the age limit may be relaxed by a maximum of five years.

4. Appointment by direct recruitment.—(1) No appointment to a specified post by direct recruitment shall be made except upon the recommendation of the Commission.

(2) No person shall be eligible for appointment to a specified post by direct recruitment, if he—

- (a) is not a citizen of Bangladesh, or a permanent resident of, or domiciled in Bangladesh;
- (b) is married to, or has entered into a promise of marriage with a person who is not a citizen of Bangladesh.

(3) No appointment to a specified post by direct recruitment shall be made until—

- (a) the person selected for appointment is certified by a Medical Board set up for the purpose by the Government to be medically fit for such appointment and that he does not suffer from any such organic defect as is likely to interfere with the discharge of the duties of the specified post;
- (b) the antecedents of the person so selected have been verified through appropriate agencies and found to be such as do not render him unfit for appointment in the services of the Republic.

5. Appointment by promotion.—(1) Appointment by promotion to a specified post shall be made after considering the recommendations of such Departmental Promotion Committee as the Government may set-up for the purpose on the basis of merit-cum-seniority for the posts of Deputy Director and above and seniority-cum-merit for the posts below the posts of Deputy Directors.

(2) A person shall not be eligible for appointment by promotion to a specified post if he has unsatisfactory service records.

6. Appointment by absorption.—Appointment by absorption to the post of Directors and Deputy Directors specified in the Schedule shall be made on the recommendation of the Superior Selection Committee set up by the Government and to other specified posts on the recommendation of Departmental Promotion Committee to be set up by Government and in consultation with the Commission.
