No. S.R.O. 402-L/85.—In exercise of the powers conferred by section 44(4) (b) of the Income Tax Ordinance, 1984 (XXXVI of 1984), the Government is pleased to exempt from tax such leasing companies established in Bangladesh as may be approved by the National Board of Revenue, for a period of five years from the date of commencement of business by such leasing companies.

No. S.R.O. 405-L/85.—In exercise of the powers conferred by section 44(4) (b) of the Income Tax Ordinance, 1984 (XXXVI of 1984), the Government is pleased to exempt the expatriate personnel employed by leasing companies and approved by the National Board of Revenue, from payment of tax for a period of three years from the date of their employment.
