No. S.R.O. 417-L/76/26-Excise.—In exercise of the powers conferred by sub-section (1) of section 12A of the Excises and Salt Act, 1944 (I of 1944), the Government is pleased to make the following further amendments in this Ministry's notification No. S.R.O. 7(D)/Exc/72, dated the 30th June 1972, namely:—

In the aforesaid notification, in the Table,-

in Sl. No. 26 in the first column, after entry (c) in the second column and the entries relating thereto in the third and fourth columns, the following shall be inserted, namely:—

"(cc) Footwear not covered by entry (c) 33 Ten per cent ad valorem".

NOTIFICATION

Dacca, the 29th November, 1976.

No. S.R.O. 417A-L/76.—In exercise of the powers conferred by sub-section (1) of section 60 of the Income-tax Act, 1922 (XI of 1922), and in supersession of the Ministry of Finance notification No. S.R.O. 17(R), dated the 1st July 1960, the Government is pleased to exempt the interest payable—

- (a) by Government or a local authority on moneys borrowed by it from outside Bangladesh;
- (b) by an industrial undertaking in Bangladesh on moneys borrowed by it under a loan agreement entered into with any such financial institution in a foreign country as may be approved in this behalf by the Government by general or special order;
- (c) by an industrial undertaking in Bangladesh on moneys borrowed or debt incurred by it in a foreign country in respect of the purchase outside Bangladesh of capital plant and machinery or with the prior approval of Government, of raw materials, to the extent to which such interest does not exceed the amount of interest calculated at the rate approved by the Government in this behalf, having regard to the terms of the loan and its repayment;
- (d) by the Bangladesh Shilpa Rin Sangstha established under the Bangladesh Shilpa Rin Sangstha Order, 1972 (P.O. No. 128 of 1972), or the Bangladesh Shilpa Bank established under the Bangladesh Shilpa Bank Order, 1972 (P.O. No. 129 of 1972), or the Bangladesh Krishi Bank established under the Bangladesh Krishi Bank Order, 1973 (P.O. No. 27 of 1973), or the Investment Corporation of Bangladesh established under the Investment Corporation of Bangladesh Ordinance, 1976 (Ord. No. XL of 1976), on moneys borrowed by it from sources outside Bangladesh, to the extent to which such interest does not exceed the amount of interest calculated at the rate approved by the Government in this behalf, having regard to the terms of the loan and its repayment;
- (e) by any other financial institution established in Bangladesh or a Bank to which the Banking Companies Ordinance, 1962 (Ord. No. LVII of 1962), applies, on moneys borrowed by it from sources outside Bangladesh under a loan agreement approved by the Government where the moneys are borrowed either for the purpose of advancing loans to an industrial undertaking in Bangladesh for purchase outside Bangladesh of raw materials or capital plant and machinery or for the purpose of import of any goods which the Government may consider necessary to import in the public interest, to the extent to which such interest does not exceed the amount of interest calculated at the rate approved by the Government in this behalf, having regard to the terms of the loan and its repayment:
- (f) by an industrial undertaking in Bangladesh on moneys borrowed by it in foreign currency from sources outside Bangladesh under a loan agreement approved by the Government, having regard to the need for industrial development in Bangladesh, to the extent to which

such interest does not exceed the amount of interest calculated at the rate approved by the Government in this behalf, having regard to the terms of the loan and is repayment;

Explanation: For the purposes of this item, the expression "foreign currency" shall have the meaning assigned to it in the Foreign Exchange Regulation Act, 1947 (VII of 1947); and

(g) by the Bangladesh Shipping Corporation established under the Bangladesh Shipping Corporation Order, 1972 (P. O. No. 10 of 1972) or the Bangladesh Biman established under the Bangladesh Biman Order, 1972 (P. O. No. 126 of 1972), on moneys borrowed by it from sources outside Bangladesh under a loan agreement approved by the Government where the moneys are borrowed for purchase outside Bangladesh of ships or aircraft, as the case may be, to the extent to which such interest does not exceed the amount of interest calculated at the rate approved by the Government in this behalf, having regard to the terms of the loan and its repayment.

MINISTRY OF FOOD NOTIFICATIONS

Dacca, the 29th November, 1976.

No. S.R.O. 418-L/76/Kha-ma/Sec-II/1F-29/76/1123.—In exercise of the powers conferred by clause (1) of paragraph 7 of the Foodstuffs Price Control and Anti-Hoarding Order, 1953, and in supersession of this Ministry's notification No. S.R.O. 150-L/639-MF-II/1F-29/76, dated the 30th April 1976 (published in the Bangladesh Gazette, Extraordinary dated the 4th May 1976), the Government is pleased to direct that no trader shall, within five-mile border-belt of Bangladesh, except the Rajshahi Statutory Rationing Area, keep in his possession or under his control more than ten maunds of foodstuffs at a time.

Explanation:

- (1) In case the stock in possession of any trader consists partly of rice and partly of paddy, the total quantity of rice and paddy shall constitute the total stock held by him.
- (2) For the purpose of this Notification, "five-mile border-belt" shall mean a depth of five miles from the coastal line excluding the territorial water of Bangladesh so far as the coastal districts are concerned.

No. S.R.O. 419-L/76/Kha-ma/Sec-II/1F-29/76/1122.—In exercise of the powers conferred by clause (4) of paragraph 7 of the Foodstuffs Price Control and Anti-Hoarding Order, 1953, the Government is pleased to rescind this Ministry's notification No. S.R.O. 149-L/638 MF-II/1F-29/96, dated the 30th April 1976 (published in the Bangladesh Gazette, Extraordinary, dated the 4th May 1976).

No. S.R.O. 420-L/76/Kha-ma/Sec-II/1F-76/11124.—In exercise of the powers conferred by clause (4) of paragraph 7 of the Foodstuffs price Control and Anti-Hoarding Order, 1953, the Government is pleased to make the following amendment in this Ministry's notification No. S. R. O. 274-L/76/860-MF-II/Con-4/76, dated the 14th August 1976 (published in the Bangladesh Gazette, Extraordinary, dated the 18th August 1976), namely:—

In the aforesaid notification, in the first paragraph, for the colon at the end of full stop shall be substituted and thereafter the proviso shall be omitted.
