**No. S.R.O. 426-L/76/S-VII/1(69)/76/1077.**—In exercise of the powers conferred by sub-section (1) of section 3 of the Shops and Establishment Act, 1965 (E. P. Act VII of 1965), the Government is pleased to suspend the operation of the provisions of sections 4, 8, 10 and 11 of the said Act in respect of the Joypurhat Sugar Mills Limited Bogra and Zeal Bangla Sugar Mills Limited, Dewanganj, Mymensingh, for a period of five months subject to the following conditions, namely:—

ORDER

Pabna, the 15th November, 1976.

Whereas it has been made to appear to this Court that Mr Anowar Hossain *alias* Ratu, son of late Abdus Samad of Kalibari, P.S. Sirajganj, Dist. Pabna, is required for the purpose of trial in this Summary Martial Law Court, Pabna, under M.L.R. 12 of 1975 in M. L. Case No. 102/76, Pabna, Sirajganj P.S. Case No. 1, dated 1st March 1976;

And whereas this Court has reason to believe that the said accused person is absconding or concealing himself to avoid appearance or arrest for the said purpose;

Now, therefore, in exercise of the powers conferred by Martial Law Regulation 3(7) of M.L.R. 1975, this Summary Martial Law Court, Pabna, hereby direct the aforesaid accused to appear in this Court, Pabna, on 20th December 1976 failing which he will be tried *in absentia* and his properties may be forfeited to the Government.
