৩। rule 2 এর sub-rule (1) এ clause (c) এর পরিবর্তে নিম্নরূপ clause (c) প্রতিস্থাপিত হইবে, যথা :—

“(c) “tender committee” means a committee constituted by the Paurashava with the following :—

- (i) Chief Executive Officer of the Paurashava; in the absence of the Chief Executive Officer, one of the member-commissioners from serial No. (ii) below to be nominated by the Chairman of the Paurashava,

২। rule 6 এর পরিবর্তে নিম্নরূপ Rule 6 এবং rule 6A প্রতিস্থাপিত হইবে, যথা :—

"6. **Functions of the tender committee.**—(1) In the case of execution of works or procurement of any materials or goods, tenders shall be invited through local news papers or by public notice in vernacular by the Member-Secretary on behalf of the tender committee.

(2) On receipt of the tenders under sub-rule (1) the member-secretary shall prepare a comparative statement of the tenders and submit it to the tender committee together with the tenders.

(3) On receipt of the comparative statement and the tenders, the tender committee shall, after scrutinising the tenders, submit them to the Chairman of the Paurashava with its recommendation or comments as may be considered necessary.

6A. **Approval of the Paurashava.**—(1) On receipt of the tenders from the tender committee, the Chairman shall convene a meeting of the Paurashava and place them before it.

(2) The Paurashava shall, after consideration of the tenders and recommendation of the tender committee, approve, subject to the provisions of rule 8, the tender which in the opinion of the Paurashava is in conformity with the specifications and conditions specified in the tender notice and is agreed by the votes of majority of the commissioners present in the meeting."
