NOTIFICATION

Dacca, the 14th December, 1976.

No. S.R.O. 435-L/76/S-VI/3R-8/76/47.—In exercise of the powers conferred by section 86 of the Local Government Ordinance, 1976 (XC of 1976), the Government is pleased to make the following amendments in the Union Parishads (Election) Rules, 1976, namely:—

In the aforesaid Rules,—

1. In rule 40,—

(i) in sub-rule (2), for clause (a), the following shall be substituted, namely:—

“(a) arrange separately the ballot boxes of the contesting candidates for election as members and Chairman and open them in the alphabetical order of the names of the contesting candidates and arrange serially the ballot papers and count the entire lot of ballot papers taken out therefrom in accordance with sub-rules (4) and (5); and”

(ii) in sub-rule (4), after the full-stop at the end, the following shall be added, namely:—

“If more than one ballot paper bearing same serial number is put in the same ballot box only one such ballot paper shall be counted in favour of that particular candidate and the other shall be treated as invalid.”

2. In rule 41, in sub-rule (1), after item (a) the following new item shall be added, namely:—
 (a1) invalid ballot papers in pursuance of sub-rule (4) of rule 40.”
3. In Form N, in item 6, after the word “cancelled” at the end, the words “and found invalid” shall be added.
