NOTIFICATION

Dacca, the 24th December, 1976.

No. 1(14)/75-T.O.—In exercise of powers conferred by section 23 read with sections 3 and 7 of the Trade Organisations Ordinance, 1961 (XLV of 1961), the Government is pleased to make the following amendments in the Trade Organisations (Classification and Affiliation) Rules, 1976, namely:—

In the aforesaid Rules;-

(I) in rule 3, in sub-rule (I), in clause (a), for the semi-colon at the end a colon shall be substituted and thereafter the following proviso shall be added, namely:—

"Provided that a Chamber which is affiliated with the Federation as 'A' class Chamber before the commencement of these rules may, by a resolution of its Executive Committee, decide to continue as 'A' class Chamber subject to having the minimum rates of admission fee and annual subscription as fixed in rule 4(1).";

(2) in rule 3, after sub-rule (2), the following new sub-rule shall be added, namely:—

"(3) Notwithstanding anything contained in clause (b) of sub-rule (I) and clause (b) of sub-rule (2), a Chamber or an Association licensed before the commencement of these rules and not having the minimum rates of admission fee and annual subscription as fixed in sub-rule (2) or, as the case may be, sub-rule (4) of rule 4, may, by a resolution of its Executive Committee for reasons to be recorded in writing, retain its existing rates of admission fee and annual subscription till December 31, 1978, and shall be classified as 'B' class Chamber or Association, as the case may be,"

- ২। জনাব অনিল চন্দ্র হাওলাদার ১৯৪৫ সালে ১লা ফের্য়ারী বাখরগঞ্জ জেলায় জন্মগ্রহণ করেন। তদানীন্তন পূর্ব পাকিস্তান সিভিল সার্ভিস পরীক্ষায় উত্তীর্ণ হইয়া তিনি ১৯৭০ সালের ৮ই ডিসেম্বর শাখা প্রধান পদে যোগদান করেন এবং পরে ১৯৭২ সালের ১৩ই জ্লাই ডেপ্টি ম্যাজিন্টেট ও ডেপ্টি কালেক্ট্র পদে নিয়োজিত হন।
- ০। তাঁহার কর্মায় জীবনে তিনি শিক্ষা মন্ত্রণালয়ের শাখা প্রধান, পট্রাখালীর ডেপর্টি ম্যাজিন্টেট ও ডেপর্টি কালেইর এবং ত্রিম হর্কুম দখল অফিসার পদে নিয়াজিত ছিলেন। পরিশেষে তিনি উক্ত পদে সিরাজগঞ্জে নিয়াজিত থাকাকালীন আকস্মিকভাবে ১৯৭৬ সালের ২৩শে নভেন্বর এপেন্ডিসাইটিস রোগে আব্রুন্ত হওয়ায় রাজশাহী মেডিকেল কলেজ হাসপাতালে প্রেরিত হন। অতঃপর ২৫শে নভেন্বর ১৯৭৬ তারিখে ডেপর্টি ম্যাজিন্টেট ও ডেপর্টি কালেইর পদে বহাল থাকা অবস্হায় তাঁহার কর্মায় জীবনের অবসান হয়। তিনি একজন সং, দক্ষ ও কর্তবান পরায়ণ অফিসার ছিলেন।
- ৪। বাংলাদেশ সরকার জনাব অনিল চন্দ্র হাওলাদারের অকাল মৃত্যুতে তাঁহার বিষবা পদ্দী ও শোকসন্তণত পরিবারের প্রতি আন্তরিক সহান্ত্তিত ও গভীর সমবেদনা প্রকাশ করিতেছেন এবং তাঁহার বিদেহী আত্মার শান্তি কামনা করিতেছেন।

The above accused persons to appear in this Court at Dacca on 22nd February 1977 at 10, a.m. in the Martial Law Case No. 72/76, failing which they will be tried in absentia and their properties may be forfeited to the Government.

The above accused persons to appear in this court at Dacca on 22nd January, 1977 at 10 a.m. in the Martiai Law Case No. 84,76, failing which they will be tried in absentia and their properties may be forfeited to the Government.

NOTIFICATION

Dacca, the 23rd December 1976.

No. S. R. O. 443-L/76.—In exercise of the powers conferred by sub-section (I of section 60 of the Income Tax Act, 1922 (XI of 1922), the Government is pleased to exempt foreign contractors, consultants and their expatriate personnel working in Bangladesh under an agreement with the Chittagong Port Authority, such agreement providing for the payment by the Chittagong Port Authority the amount of tax payable by such foreign contractors, consultants and their expatriate personnel in respect of income derived by them, from so much of the tax on their income received or deemed to be received by, or accruing or arising or deemed to accrue or arise to them in Bangladesh as exceeds the tax that would have been payable by them had the said Chittagong Port Authority not entered into the agreement to pay such tax on their becalf.

This notification shall be deemed to have taken effect from the assessment year 1973-74.
