NOTIFICATION

Dacca, the 28th December, 1976.

No. S.R.O. 446-L/76.—In exercise of the powers conferred by sub-section (1) of section 15D of the Income-tax Act, 1922 (Act XI of 1922), the National Board of Revenue is pleased to approve Community Health Research Association, Dacca, for purposes of that section subject to the following conditions:

- (1) that the accounts of Community Health Research Association shall be audited every year by Chartered Accountants. And a copy of such audited accounts shall be submitted every year to the Deputy Commissioner of Taxes in whose territorial jurisdiction the head office of the Community Health Research Association is situated;
- (2) that Community Health Research Association shall not make any donation or grant to any other charitable institution or fund unless it is an institution or fund approved under section 15D(1) of the Income-tax Act, 1922; and
- (3) that in the event of dissolution of Community Health Research Association, its assets left after meeting its liabilities, if any, shall be transferred to another institution or fund approved under section 15D of the Income-tax Act, 1922.

No. S. R. O. 448-L/76.—In exercise of the powers conferred by Chapter IXA of the Income-tax Act, 1922 (XI of 1922) read with sub-section (1) of section 58L, the National Board of Revenue is pleased to direct that the following further amendments shall be made in the Income-tax (Provident Funds) Relief Rules, the same having been previously published as required by sub-section (4) of section 59 of the Income-tax Act, 1922 (XI of 1922), namely:

Amendment

In the aforesaid rules, in rule 4, for sub-rule (3) the following shall be substituted, namely:

- (3) No such withdrawal shall exceed—
 - (a) the pay of the employees for three months or in the case of withdrawals for the purpose specified in clause (e) of sub-rule (1), the pay of the employees for six months, or, the total of the accumulation of exempted contributions and exempted interest contained in the balance to the credit of the employee, whichever is less;

- (b) in the case of withdrawals for the purpose specified in clause (d) of sub-rule (1), eighty per cent of the total of accumulation of exempted contribution and exempted interest standing to the credit of the employee; and
- (c) in the case of withdrawals for the purpose specified in clause (e) of sub-rule (1), the restriction imposed by clause (a) shall apply to each withdrawal and not to the total withdrawals.
