No. S.R.O. 2-L/81/SIV/MWB-8/80/3.—In pursuance of the provisions of sub-section (1) of section 3 of the Minimum Wages Ordinance, 1961 (XXXIX of 1961), read with sub-rules (6) and (7) of Rule 4 of the Minimum Wages Rules, 1961 and in partial modification of the Notification No. S.R.O. 103-L/80/LIWVI/2(22)/78, dated the 26th April, 1980, the Government is pleased to appoint Md. Shah Alam, the present President of the Bangladesh Cinema Hall Industries Sramik Federation in place of Mr Faquir Amir Hossain, as Member of the Minimum Wages Board for the purpose of discharging its function in respect of making recommendation for Minimum rates of wages for the Workers employed in the cinema hall industry in Bangladesh with immediate effect.

#### MINISTRY OF FOOD NOTIFICATION

#### Dacca, the 3rd January 1981

- No. S.R.O. 4-L/81/9-MF/S-7/IF-29/77,—In exercise of the powers conferred by sub-clause (1) of clause 7 of the Foodstuffs Price Control and Anti-Hording Order, 1953, and in supersession of all notifications issued in this behalf, the Government is pleased to direct that subject to the provisions specified in this Notification—
  - (a) no wholesaler or retailer, outside one mile border belt of Bangladesh, shall keep in his possession or under his control rice or paddy in excess of—
    - (i) five thousand maunds in case of a whosesaler; and
    - (ii) two hundred and fifty maunds in case of retailer.

Explanation: In case the stock in the possession of any wholesaler or retailer consists partly of rice and partly of paddy, the total quantity of rice and paddy shall constitute the total stock held by him.
